
Board members shared a number of events that they were in attendance over the last month.

C. Superintendent's Remarks

Our schools collectively raised an astounding \$22,865.35 in support of cancer research by participating in the 2023 Terry Fox School Run past fall. The Terry Fox Foundation commends the leadership of our Board for championing philanthropy and fostering a culture of giving within our schools!

Students from Signal Hill Elementary and La Vallée presented their "Chair of the Future" project to the Squamish-Lillooet Regional District (SLRD) on April 25th. Signal Hill Elementary student, Rose, gave an



excellent speech with some powerful words about environmental stewardship. The recording of the meeting can be found on SLRD's YouTube channel.

Red Dress Day - May 5 was the National Day of Awareness for Missing & Murdered Indigenous Women and Girls and 2SLGBTQI+ people (MMIWG2S), also known as "Red Dress Day," coined by Métis artist Jaime Black as "an aesthetic response to this critical national issue." The ongoing crisis of missing and murdered Indigenous women, girls, and 2SLGBTQI+ people that we are facing is a direct result of colonization. In Canada, more than six in ten (63%) Indigenous women have experienced physical or sexual assault in their lifetime. The impact of these disproportionately high rates of violence is felt in all areas of life. Additional information can be found on the school district's website.






ANNUAL BUDGET BYLAW

A Bylaw of THE BOARD OF EDUCATION OF SCHOOL DISTRICT NO. 48 (SEA TO SKY) (called the "Board") to adopt the Annual Budget of the Board for the fiscal year 2024/2025 pursuant to section 113 of the School Act, R.S.B.C., 1996, c. 412 as amended from time to time (called the "Act").

- 1. Board has complied with the provisions of the Act respecting the Annual Budget adopted by this bylaw.
- 2. This bylaw may be cited as School District No. 48 (Sea To Sky) Annual Budget Bylaw for fiscal year 2024/2025.
- 3. The attached Schedule A showing the estimated revenue and expense for the 2024/2025 fiscal year and the total budget bylaw amount of \$78,176,307 for the 2024/2025 fiscal year was prepared in accordance with the Act.
- 4. Schedule A and B are adopted as the Annual Budget of the Board for the fiscal year 2024/2025.
