**WHAT THIS BILL DOES:** **OPPOSE** [HB1181](#) requires cremation or burial of aborted fetal tissue; **OPPOSE** [HB1233](#) school discrimination and exclusion against transgender students; **OPPOSE** [HB0928](#) "Tennessee Second Amendment Sanctuary Act," declares any federal gun laws unenforceable and prohibits state and local government from enacting gun laws

**[SCRIPT]:** "I am contacting you as your constituent, to ask you to vote no on HJR185M, no on HB0529, no on HB0978, and no on HB0928. "I am contacting you to urge you to vote against HB1181 before you this week. This bill would require fetal remains from an abortion to be cremated or buried. It is obviously meant to shame individuals surrounding their decisions. It is not the government's place to interject in these personal and private decisions. Additionally, this legislation would result in increased costs that would be unfairly imposed on abortion facilities. There is a similar law that is currently being challenged by the ACLU in Ohio, I would urge you not to waste my tax dollars on these bills. I am contacting you to urge you to vote no on bill HB1233, which improperly dignifies the idea that it is acceptable not to share space with fellow transgender students. This bill would identify, target, and stigmatize transgender students, which would be very harmful for their mental health and well being. Additionally, this bill would impact state and local budgets that would be associated with school compliance measures, as well as possible civil litigation. Please consider voting no and stand in support of transgender students. I am also asking you to vote no on HB0928 the "Tennessee Second Amendment Sanctuary Act," that would nullify federal gun laws and prohibit state and local governments from enacting gun laws. This bill is dangerous and I don't think Tennessee should be picking which federal laws it chooses to follow and which ones

it breaks. This is obviously a challenge to federal laws that Tennessee should follow and would surely waste taxpayer dollars in court.

Additionally, this bill would impact state and local budgets that would be associated with school compliance measures, as well as possible civil litigation. Please consider voting no and stand in support of transgender students. I am also contacting you to vote in favor of SB1380. This bill would prohibit magistrates from issuing no-knock warrants and also require the police to establish policies regarding de-escalation tactics and the use of force. It is important that we do everything possible to reduce violence, the use of force, and unintended shootings by the police. There are way too many incidences not to take action to change our policies."

**[SCRIPT]:** "I am contacting you to ask you to vote no on SB1370, no on SB1224, no on SB0557, no on SB0843, no on SB0457, yes on SB0647, and yes on SB0003 before you in the Senate Judiciary Committee this week. I would like to ask you to vote no on SB1370, which states that there is no cause of action for wrongful birth or wrongful life and redefines life as beginning at fertilization. This bill's attempt to redefine personhood at fertilization could potentially create grounds for suing health providers, in vitro fertilization clinics, and women for pregnancy outcomes. This bill offers zero value as there are no examples of someone filing a lawsuit for wrongful life, however, it could create very large litigation expenses for the state as it infringes on women's reproductive rights and potential fallout for healthcare providers. I would also like for you to vote no on SB1224, which would requires businesses and public buildings with transgender-inclusive restrooms to post signs. This bill is an effort to intimidate transgender people about restrooms and intimidate businesses

that support inclusive restrooms. These signs will endanger transgender people and could lead to aggression against trans-inclusive businesses. I would urge you to consider how this legislation might impact the lives and safety transgender individuals and the overall negative impact this will have on communities, businesses, and the economy of Tennessee. I am also asking you to vote against SB0557 which would not allow the federal government to regulate guns. This bill is dangerous and I don't think Tennessee should be picking which federal laws it chooses to follow and which ones it breaks. This is obviously a challenge to federal laws that Tennessee should follow as part of the United States and would surely waste taxpayer dollars in court. I am also asking you to vote no on SB0843, because this bill seeks to criminalize our first amendment rights. SB0843 changes the penalties from misdemeanor to felony and also creates new criminal offenses surrounding actions involving demonstrators. A felony charge is too severe a penalty. Demonstrators, whether you agree or disagree with their cause, are exercising their first amendment right, freedom of assembly. This bill intentionally seeks to discourage people from demonstrating, which is protected under our constitution. This bill also carries a high fiscal cost to our state and it is highly likely that this bill, if passed, will face significant legal challenges and incur high litigation costs to Tennesseans, while providing no benefits. I would also like to ask you to vote no on SB0457. This bill requires training for Nashville Community Oversight Board members and invalidates their authority until all members have completed this training. I believe this is a local decision that the people of Nashville and their elected officials should decide. This bill is government overreach and interference, especially given that the bill sponsors and co-sponsors represent constituents that live outside of Nashville and Davidson County. I am also asking you to support SB0647, which seeks to limit some of the financial obligations associated with the restoration of voting rights. SB0647 would restore voting rights through provisional voting if a person enters into a payment plan for victim restitution. Placing financial hurdles on individuals trying to re-establish their lives is not only unfair but also completely unrelated to the right to vote. The current law is voter suppression of the poor and responsible for disenfranchising voters based on their economic status. With Tennessee having one of the country's lowest voter turnout rates, we should be doing everything possible to increase voting. I am also asking you to support and vote yes on SB0003 which would create a non-partisan redistricting committee in order to create fairer voting districts for the revised census. I believe this is at the heart of our democracy and allows for votes to be more evenly and fairly represented and counted. Partisan biased voting maps disenfranchise voters by giving certain groups more power and say in elections and ultimately in our government."

**[SCRIPT]:** "I am contacting you to ask you to vote no on bill HB1143, yes on bill HB0413, and yes on HB1393, and yes on HB1406 before you in the House Criminal Justice subcommittee on Wednesday of this week. I am urging you to vote no on HB1143, because this bill would change the punishment from misdemeanor where it stands currently, to a felony for violations associated with driving with a license that is canceled, suspended, or revoked. This is way too severe a punishment for this type of driver's licence violations. The result of this legislation could lead many to lose or hinder future employment, lose their right to vote, and negatively impact their immigration status. Additionally, this bill carries a large fiscal impact of over \$4.3 million annually to our state budget due to the increased strain to our court and criminal justice system. I don't believe a stiffer punishment will do anything to prevent or deter these offenses and will cost our state millions. I am also asking you to support and vote yes on HB0413. This bill would decriminalize marijuana possession or exchange for amounts under an ounce. Currently the law stands that possession or casual exchange, not sale, for under a half ounce is a misdemeanor and over half an ounce is a felony, and these bills would change that to an ounce. These bills would save thousands of individuals from the trauma of arrest and incarceration. Small amounts of marijuana possession has permanently and negatively impacted lives and communities. Additionally, this bill would save Tennessee millions in decreased expenditures on incarcerations at both state and local level. We shouldn't be using taxpayer dollars to prosecute and incarcerate people for these actions. I am also asking you to support HB1393, which seeks to limit some of the financial obligations associated with the restoration of voting rights. HB1393 would restore voting rights through provisional voting if a person enters into



a payment plan for victim restitution. Placing financial hurdles on individuals trying to re-establish their lives is not only unfair but also completely unrelated to the right to vote. The current law is voter suppression of the poor and responsible for disenfranchising voters based on their economic status. With Tennessee having one of the country's lowest voter turnout rates, we should be doing everything possible to increase voting. I am also contacting you to ask you to vote in favor of SB1380. This bill would prohibit magistrates from issuing no-knock warrants and also require the police to establish policies regarding de-escalation tactics and the use of force. It is important that we do everything possible to reduce violence, the use of force, and unintended shootings by the police. There are way too many incidences not to take action to change our policies."

I am asking you to vote no on HJR0140 because an added amendment by the bill sponsor would prohibit the General Assembly from authorizing by law "the use of a substance, other than that prescribed by an authorized physician." This amendment clearly targets future marijuana legalization bills. Each elected General Assembly should be able to write and pass bills based on knowledge, health and government guidelines, and constituent input. This amendment oversteps future General Assemblies and defines all legal substances based on criteria determined in 2020."

**[SCRIPT]:** "I am contacting you to urge you to vote no on HJR0072 before you in the House Finance, Ways, and Means Committee. In other states similar laws have resulted in driving down wages and increasing workplace injuries and fatalities. Additionally, this bill would add this constitutional amendment to the 2022 general election ballot, resulting in increased local government expenditures. Tennessee is already considered a "right to work" state due to current laws. Not only is this bill harmful to workers but it is unnecessarily costly to our counties. Please vote no and protect working families in Tennessee."
