1. General Terms

This document outlines the wholesale pricing and distributor policies for Notes to Self: A Guided Mindful Practice Journal. These policies apply to all wholesale customers, including retailers, distributors, and other businesses.

2. Wholesale Pricing

- **Wholesale Price:** The wholesale price for Notes to Self is \$9.99* This price is subject to change without notice.

- **Minimum Order Quantity:** The minimum order quantity for wholesale customers is 5 units.

3. Payment Terms

- **Full Payment Due Upon Ordering:** Full payment is due upon receipt of the order. We accept all major credit cards.
- **Orders Placed Online:** Orders may be placed online at www.blossompianostudio.com/notes-to-self-practice-journal with the corresponding code (as listed above).
- **Resale Certificate:** If you have a valid Resale Certificate or Certificate of Exemption, please provide it at the time of purchase to avoid sales tax.

4. Shipping and Handling

- **Shipping Costs:** Shipping costs will be calculated based on the customer's location and the shipping method chosen.

5. Returns and Exchanges

- **Damaged or Defective Goods:** If the customer receives damaged or defective goods, they must notify us within 5 business days of receipt. We will replace the damaged or defective goods at no cost to the customer.
- **Customer Returns:** We do not accept returns for non-damaged goods.

6. Distributor Agreement

- **Marketing and Promotion:** Distributors are responsible for marketing and promoting Notes to Self. We may provide marketing materials and support.

7. Amendments

We reserve the right to amend these wholesale pricing and distributor policies at any time. Any changes will be communicated to our wholesale customers in writing.

Wholesale Distributor Agreement

1. Parties

This Agreement is made and entered into as of [Date] by and between Blossom Piano Studio (the "Company") and _____ (the "Distributor").

2. Purpose

The purpose of this Agreement is to establish the terms and conditions under which the Distributor will distribute the Company's products, specifically Notes to Self: A Guided Mindful Practice Journal (the "Products").

3. Products

The Distributor agrees to purchase and distribute the Products in accordance with the Company's wholesale pricing and terms.

4. Wholesale Pricing

The wholesale pricing for the Products is as follows:

5. Orders and Delivery

- The Distributor must place orders in writing or electronically.
- The Company will deliver the Products to the Distributor at the designated shipping address.
- Shipping costs will be calculated based on the customer's location and the shipping method chosen.
- The Company will use reasonable efforts to deliver the Products on a timely basis. However, the Company shall not be liable for any delays in delivery caused by circumstances beyond its control.

7. Payment Terms

- The Distributor must pay for the Products in full upon receipt of the invoice.
- Full payment is due upon receipt of the order. We accept all major credit cards.
- **Resale Certificate:** To avoid sales tax on wholesale orders, the Distributor must provide a valid Resale Certificate or Certificate of Exemption at the time of purchase.

8. Marketing and Promotion

The Distributor agrees to actively market and promote the Products in the designated territory. The Distributor will use its best efforts to increase sales and brand awareness.

9. Sales Reporting

The Distributor must provide the Company with quarterly sales reports, including the number of units sold, revenue generated, and any other relevant information.

10. Returns and Exchanges

- The Distributor may return damaged or defective Products to the Company within 5 (five) business days of receipt. The Company will replace the damaged or defective Products at no cost to the Distributor.
- We do not accept returns for non-damaged goods.

11. Termination

Either party may terminate this Agreement for any reason upon 7 days' written notice to the other party.

12. Governing Law

This Agreement shall be governed by and construed in accordance with the laws of the Commonwealth of Massachusetts.

13. Entire Agreement

This Agreement constitutes the entire agreement between the parties and supersedes all prior or contemporaneous communications, representations, or agreements, whether oral or written.
