#### Discussion Items (2:30-4:30, preceded by a BREAK)

- 2:30 Recommendation to expedite PO DEA approval when there's already an approved FO (Fred Teti)
  - Approved w/ the stipulation that Fred add "at the time of bridging" in order to make the processing time manageable and the DEA scheduling option clear to students.
- 2:40 Course frequency language edits (Tom Boegel)

- The CC approved of the edits, simplifying the list by removing four lines and eliminating the need for two dropdowns. Members hope that this list will be embedded in CQnet (Codes and NoOtes?) so that information will move more smoothly from outlines to Banner.
- 2:45 Legislative Update w/ Rachel Cohen
  - One of Rachel Cohen's best segments yet. An archive of slideshows from Rachel's very popular segment is being built. In this segment, Rachel addressed a foundational question: What is articulation? As she said on 10/26, "One of the things I found out since taking this job is that hardly anyone knows what [articulation] is." She discussed various types of agreements, including course-to-course alternatives to GE, and distinguished GE from graduation requirements. Rachel also looked at articulation in the context of upcoming CalGETC and AB 928 changes.
- 3:00 Finalize GE Area <u>definition recommendations</u>
  - Members were given one more week to respond asynchronously, but there was general agreement over the choices. Each definition will be presented for formal recommendation approval at the next meeting.
- 3:15 Mediating external agency and CC expectations (Megan Corry)
  - Megan gave an excellent <u>presentation</u> on several of the challenges faced by CTE departments such as her own that are looked at very closely by external accrediting groups with their own language expectations in outlines. The college catalog lists these outside groups. Besides offering a number of specific course and agency examples, Megan steered the discussion to the importance of tech reviewers and CTE originators communicating clearly about explicit requirements outside of CC Handbook parameters. Those outlines also need to include state regulatory language and must meet the expectations of outside agencies.
- 3:30 BREAK (in 3D for Halloween)
- 3:35 SLO Meta discussion (Janey Skinner)
  - o Janey shared results from the recent meta slo assessment and encouraged discussion connecting assessment and curriculum development. How well have our assessment practices worked not just for gathering and analyzing quantitative and qualitative data, but how well have our processes helped curriculum development processes? Colleagues reported that SLO assessment can be very satisfying when it's clear that it feeds into improvements and doesn't feel like just a compliance task. Collaboration and dialogue have also made the process more enjoyable and production. Alternative approaches to CRN-level assessment were presented, and new ideas were generated. Many ideas had to do with timing and slo sequence, as well as improving the incorporation of aggregate reporting. There was also talk of assessing program outcomes directly instead of just relying on course-to-program slo mapping. What's been lost or gained by switching the 3-yr aggregate schedule to a schedule driven by the curriculum revision cycle. What's gained by drilling into a single outcome for an entire year? Could that help with targeting gaps? What about direct feedback and self-assessment from program completers? Might different assessment approaches lead to reinvigorated reflection and curriculum development?
- 4:05 Recommendation to remove option 3 for satisfying Area B (Karen Cox)
  - Members agreed that the 1B/1C option is problematic because it has made a rare situation with SFSU students into a policy norm. Approved w/ the stipulation that the 1B/1C line be replaced with one acknowledging 1A-equivalent courses from accredited institutions that are approved by the English Department. Karen's new version is to be reviewed by members of English and the Curriculum Committee, including Rachel, before it is presented as a resolution to the ASEC. This revised language needs to be in the fall catalog.
