...I am very concerned about some of the materials used in the World History class' study of religions...[which] contain inaccurate and misleading statements about both historical events and the teachings of Judaism and Christianity.

The most glaring example is the absurd contention set forth in an excerpt from "A Muslim Primer" that "social and economic reasons are forcing the [Roman Catholic] Church to consider polygamy as an Christian option". There are literally hundreds of books about Islam available, and I seriously question the use of material which contains such a ridiculous and untrue claim. That chapter also contains several other significant misstatements and omissions...

...It will help our conversation if you can highlight specific incorrect statements, so we can be clear about your concerns during our conversations. We already know about the footnote referencing polygamy. That level of specificity is very helpful...

The first six months of 2012 were concentrated on the removal of the <u>Arab World Studies Notebook</u>, which had come to public attention and was more widely used (at least seven chapters) than the single chapter of <u>A Muslim Primer</u>. The Notebook was removed in late June, 2012.

After being told in August, 2012 by Deputy Superintendent for Teaching and Learning Ann Frederick that our concerns about class materials would "never" be listened to and that parents concerned about the curriculum should "find another school", we focused on obtaining class material to prepare for filing an action with the state education department.

During this time I also corresponded extensively and met with School Committee Geoff Epstein, who eventually recommended to Superintendent David Fleishman that we meet to discuss resolving our differences. Unfortunately his recommendation was not followed. Mr. Epstein decided not to run for re-election, and since then we have not met with any School Committee members.
