

Privacy policy

Noise Wave takes the privacy of our customers and users seriously. We recognize that privacy is an important issue, so we design and operate our services with the protection of your privacy in mind. This Privacy Policy explains what kind of information we collect, and use, and the security of your information in relation to our mobile services. By using our services, you consent to this privacy policy.

1. How we protect your information

Our primary purpose is to provide you with a safe, smooth, efficient, and customized experience. We may collect non-personal identification information about you, including information in the following categories:

1) Information collected by our Third Party Advertising Partners

We work with third-party advertising partners to provide personalized ads for you. Our partners include but are not limited to Google AdMob, DoubleClick Ad Exchange, DoubleClick for Publishers, Facebook Audience Network, MoPub, Amazon, Fyber, Smaato, Appsflyer, etc.

Our partners may collect hardware and software information such as IP address, device ID and type, and advertising IDs (such as Google's AAID and Apple's IDFA, both of which are randomly generated numbers that you can reset by going into your device's settings), device language, operating system, time zones, and

identifiers associated with cookies or other technologies that may uniquely identify your device.

2) Collect None of Your Personal Information

We do not collect any Personal Information through the Keyboard app. Personal Information includes your name, physical address, social numbers, email address, and geographic location information.

3) Non-Personal Information Collected

We collect Non-Personal Information. “Non-Personal Information” is information that does not identify you or any other individual and includes Session and Usage Data, Log Data, and Aggregate Information.

2. Data and usage

Generally, we may use Non-Personal Information and message data for internal purposes only, such as to provide you with Noise Wave, to notify you of new products or services, or an ad for promotion and marketing purposes. We do not combine Non-Personal Information with Personal Information.

We do not disclose your information to third parties for the third parties' direct marketing purposes unless you first affirmatively agree to that disclosure.

3. Third-party keyboard warnings

When you allow full access in the settings under add new keyboard tab, you will encounter a warning message stating “full access allows the developer to transmit anything you type, including things you have previously typed with this keyboard. This could include sensitive information such as your credit card number or street address.”

Fonts Products are designed Not to receive, store or transmit any such sensitive data.

4. Information security

Noise Wave is very concerned about safeguarding the confidentiality of your information. We do not collect Personal Information, and we employ administrative, physical, and electronic measures designed to protect your Non-Personal Information from unauthorized access and use. Please be aware that no security measures that we take to protect your information is absolutely guaranteed to avoid unauthorized access or use of your Non-Personal Information or is impenetrable.

5. Compliance with laws and law enforcement

We cooperate with government and law enforcement officials to enforce and comply with the law. We may therefore disclose Session, Usage Data, Message Data, and any other information about you, if we have a good faith belief that it is reasonably necessary to (1) satisfy any applicable law, regulation, legal process or enforceable governmental request, (2) enforce our Terms of Use, including investigation of potential violations thereof, (3) detect, prevent, or otherwise address fraud, security or technical issues, or (4) protect against harm to the rights, property or safety of Noise Wave, its users or the public as required or permitted by law.

6. Children's privacy

Noise Wave does not knowingly collect Personal Information from children under the age of 13. If you are under 13, please do not attempt to register or send any information about yourself to us, including your name, address, telephone number, or email address. By using our Site or Services, you promise that you are at least 13 years old. If we become aware that we have inadvertently received Personal Information from a child under the age of 13, we will delete such information from our records. If you believe that we might have any information from or about a child under 13, please contact us at support@brilic.com. In addition, we recommend that

minors 13 years of age or older ask their parents for permission before sending any information about themselves to anyone over the Internet.
