Instead of appreciating the concern of an Officer and a Whistle Blower and taking necessary corrective action; they have collectively resorted to harassing and victimizing me abusing their positions of Power . Is the Management of HPCL not accountable to the Ministry of Petroleum? Will MOP&NG please take any action against the CMD and Directors in view of the long pending Grievance Petition dated 30/12/03 and the complaint dated 4/7/06 against Shri M.B.Lal?
