

Paxton-Buckley-Loda Unit #10 2025-2026 Health Requirements

Preschool Students:

- Physical Exam (completed on IL Certificate of Child Health Exam Form). Parent/Guardian must complete the yes/no questions on the back and sign and date.
- Complete immunization record signed by a doctor: (4) DTap, (3) Polio, (4) Hib, (3) Hep B, (1) MMR, (1) Varicella, (4) Pneumococcal

Kindergarten Students:

- Physical Exam (completed on IL Certificate of Child Health Exam Form). Parent/Guardian must complete the yes/no questions on the back and sign and date.
- Complete immunization record signed by a doctor: (5) DTap, (4) Polio, (4) Hib, (3) Hep B, (2) MMR, (2) Varicella, (4) Pneumococcal
- Dental Exam on IL form due May 15, 2026 (dated within 18 months of May 15

th deadline)

- Eye Exam on Illinois form dated within one year of the first day of school

Second Grade Students:

- Dental Exam on IL form due May 15, 2026 (dated within 18 months of May 15

th deadline)

Sixth Grade Students:

- Physical Exam (completed on IL Certificate of Child Health Exam Form). Parent/Guardian must complete the yes/no questions on the back and sign and date. Sports Physicals are NOT acceptable for this requirement.
- Completed immunization record signed by health care provider, including (1) Tdap, (1) Meningitis
- Dental Exam on IL form due May 15, 2024 (dated within 18 months of May 15

th deadline)

Ninth Grade Students:

- Physical Exam (completed on IL Certificate of Child Health Exam Form). Parent/Guardian must complete the yes/no questions on the back and sign and date. Sports Physicals are NOT acceptable for this requirement.
- Completed immunization record signed by health care provider.
- Dental Exam on IL form due May 15, 2024 (dated within 18 months of May 15

th deadline)

Twelfth Grade Students:

- Proof of receiving (2) Meningitis vaccinations: First dose received on or after the 11th birthday and second dose received on or after the 16th birthday. Only one dose is required if the first dose was received at 16 years of age or older.

New Students:

- Any student enrolling in an Illinois school for the first time must have a Physical Exam on IL form, completed immunization record signed by a health care provider, and Eye Exam on IL form on file with the school by October 15 or within 30 days of enrollment.
- Students transferring from another Illinois school must provide the above for their respective grade within 30 days of enrollment.

October 15, 2025 is the deadline for all required health information

All physicals and immunization records must be turned in to the school office no later than October 15, 2023 or your child will face exclusion from school until documentation is received. Paxton Buckley Loda Unit #10 must have documentation of when the vaccine was administered in order for your child to be in compliance with State of Illinois requirements - a verbal statement of vaccination status is not accepted. Please speak with your child's healthcare provider about your child's vaccination/physical needs. The Ford County Health Department has vaccination options available for various forms of Medicaid/insurance.
