

FAFSA/CADAA Updates



A relatively new state law (AB 469) requires all graduating seniors to complete a Free Application for Federal Student Aid (**FAFSA**) or California Dream Act Application (**CADAA**). This will help determine if they qualify for free money for college (community college, 4-year university, or trade school) in the 2026-2027 school year. Many students are eligible for federal or state aid and weren't even aware, even for family incomes up to \$250,000/year. Opt out is available after meeting with your counselor, but not recommended.

Full-time, First Year Community College students are eligible for "Two Years Free" Programs at all California Community Colleges, per AB 19. The program is NOT income-dependent but to be eligible, a FAFSA or CADAA must be completed by the March 2nd priority deadline!

The FAFSA and CADAA were updated two years ago to be more simplified and streamlined (<u>FAFSA Simplification Act</u>). The **2026-27 FAFSA and CADAA** can be submitted from **October 1**, **2025-March 2**, **2026**. You are encouraged to submit your application as soon as possible after it opens. You will use income from the **2024*** tax year and the FAFSA will automatically transfer income tax data. The new FAFSA requires every household income contributor to create an FSA ID account (digital signature). **Avoid delays by having every contributor create an FSA ID account now at https://studentaid.gov/fsa-id.**

Cal Grant- free state aid!

Cal Grant recipients receive free tuition at UC and CSU! Income caps are probably higher than you think (up to \$144,700 for a family of 4 with at least a 3.0 GPA)- Cal Grant Income Ceilings for 2026-27

To be considered for a 2026-27 Cal Grant award, students only need to complete a FAFSA or CADAA. Horizon has already electronically submitted a certified Cal Grant Grade Point Average (GPA) to the California Student Aid Commission (CSAC). There is no need to fill out a Cal Grant GPA Verification Form.

Once you have submitted your FAFSA, be sure to create a student WebGrants account at https://mygrantinfo.csac.ca.gov/. You are required to confirm your college and confirm HS graduation.

*Students who experienced a decrease in parental income in 2025 should still complete the FAFSA with 2024 income and then follow up with each college's Financial Aid office to explain the special circumstance.
