Angel Fashion Show Deposit

All deposits are FINAL SALE and **are non-refundable and non-transferable** to future shows. Exceptions for personal, financial, medical, and professional conflicts **WILL NOT** be considered. If you can no longer participate, please contact customerservice@acbikinis.com. Any available accommodations will not be accepted or offered if the show you signed up for has already occurred.

If you purchase the Angel Fashion Show deposit and package and wish to transfer to another show, you will need to put the \$99 deposit down for the show you wish to transfer to. We will not charge you any other fees to transfer to a different show. Note that if you do transfer to another show after you have placed your full package order, you will have a different activewear set. If you wish to purchase the specific activewear set to your transferred show, we will invoice you for the new set.

New Order Confirmation

All orders are reviewed and processed in the order they are received. All customers will receive an email confirmation notification to the email address entered on the order form. Please review the order confirmation email immediately to make sure your selections are accurate. Please email your suit specialist or customer service if anything looks wrong. All recommendations and selections are accepted on your own accord, even if a suit specialist completed the order for you.

Any orders with past due or unpaid invoices will not ship until all balances have been paid. AC Bikinis is not responsible for late shipments due to past due payments not being received on time. In the event partial payment is received, but the order is canceled, all partial payments may be refunded 100% via store credit only. If expedited shipping is requested or necessary on an order form, AC Bikinis will email an invoice or ordering link for expedited shipping to the customer. Orders will not ship with expedited shipping unless the invoice is paid by the expected ship date. Please refer to the "Domestic and International Shipping Policy and Changes after the order has been placed" section at the bottom of page for more information regarding shipping terms.

Request to Hold Production on New Order

Order forms that include a clearly written note request to "not start production", "hold for Black Friday", or "wait for size/measurement confirmation", will be placed on hold at the Customer Service stage. Production will not begin until the customer or suit specialists provides the customer service department with the confirmation to process the order. (Email customerservice@acbikinis.com). The selected production turnaround time will be effective the date order confirmation to process is received, not the date the order was placed. Any changes will be subject to availability at the time of order finalization and any applicable fees. The discount code used at the time the order was submitted will be guaranteed on

additions. But the MSRP of the additions will be equal to the current prices listed, not at the time of order submission.

Custom Top Size and Custom Bottom Cut Requests

Angel Competition Bikinis offers custom dimension top sizes and custom dimension bottom cuts for \$50.00 each. Custom requests will add 1 week to your selected production turnaround time. If you are a new customer, we highly recommend first trying a standard top size or bottom cut first before deciding to order a custom size. Our skilled sewing manager will accommodate your requests as closely as possible and will notify you of any recommended changes to provide you with your desired fit. Our experienced sewing team will do their best to create a custom cut to your specifications keeping in-line with the style and fit of AC Bikinis. Due to the nature of fabric and crystals, there can be a 1/4" variance from the original specifications.

Custom tops and bottoms are eligible for our Full Suit Return Policy (see policy details below). All edits needed to the current custom cut version is subject to an additional \$50.00 fee.

Return, Refund and Exchange Policy for Competition Suits for Fashion Show.

All Angel Fashion Show orders are FINAL SALE and not eligible for refund or cancellation. AFS apparel is non-returnable and non-exchangeable. We do have an option for a re-order on apparel items.

In the event your suit or apparel does not fit, or you are not happy with your suit, a refund may be issued via store credit voucher only for the competition suit only. All 2025 AFS Package Custom build suits and Couture gowns are priced so the base cost of the suit is 100% off and all upgrades are charged for. Suits may be returned for a **100% store credit voucher for the package value of the suit plus any upgrades.. Pre-owned suits are only available for 60% store credit when the rental option is selected.** The total amount issued will not include the cost of the selected shipping method on the original order. The store credit is a voucher discount code and will discount your order the exact amount of the suit package MSRP. It can not be combined with any other discounts and can only be redeemed on one order. Any remaining balance will not be transferred to a future order. Voucher codes will be issued when we have received the original full suit or single piece order back, in an unaltered state, unworn condition, with no tanning or bodily residue residue, and all tags and hygienic liners attached. If a full suit was purchased on the original order, the full suit must be returned for store credit.

To receive your voucher code faster, customers may send a photocopy of a shipping receipt to customer service that shows the tracking number and estimated delivery date back to AC Bikinis. The voucher code will be issued when proof of package drop off has been updated on the return tracking. Refunds via payment method will only be issued upon receiving the suit back. Ready to ship suits will not be refunded until the suit has been returned and inspected.

PLEASE NOTE: A \$30.00 cleaning fee will be automatically deducted from your suit return amount if the suit has any signs of wear, tanning residue, bodily residue, is missing tags, or does not have the hygienic liners. This will not be negotiated and will be determined at ACBikinis' discretion.

If you believe there is a mistake with the production of your suit and you did not receive what you ordered, please email your suit specialist. Although unlikely, if an error was made on our part, we will make sure to correct it in time for your show at no cost to you.

Return or Exchange Policy for Angel Fashion Show Active Wear

Angel Fashion Show branded activewear is considered customized and not available for return or exchange. In the event your activewear does not fit, you may be able to purchase additional sizes at a discounted price. Please contact customerservice@acbikinis.com for approval. Apparel images and logo options are subject to change without notice. Image representations may be different from what is shown on the website order package.

Angel Couture Orders and Return Policy

- Please submit ordering questions to your suit specialist. After an order is placed, any questions can be directed to customerservice@acbikinis.com. Please include COUTURE and your ORDER # in the subject line. All emails will be answered by the appropriate couture product manager(s).
- All orders must be paid in full at the time of submitting your order. If you need to request a deposit please speak with a suit specialist. All deposits are non-refundable.
- All Couture suits and accessories are processed with a standard 8 week production turnaround. If a faster turnaround is necessary, we offer a 4 week production turnaround for \$150.00.
- Current molded style top sizes and bottom cuts apply to the Couture Division. We highly recommend purchasing a posing suit first to ensure your couture suit fits perfectly.
- Brazilian bottom cut is recommended for this division.
- Production order changes after an order has been placed will be reviewed on a case-by-case scenario. Some changes may be allowed and subject to additional costs.
- All pricing includes base options only selected on order form. Any additional requests are subject to approval first and additional costs.
- All suit orders are eligible for the 365 day warranty policy. In the event, suit applique or crystals fall off, AC Bikinis does use E600 glue to adhere the material back on.
- Couture Suits and small accessories are eligible for the 100% return policy via store credit only. Same terms apply. Please email customer service for approval.
- *Large accessories such as gowns and wings* are 100% custom and not eligible for the return policy.
- With approval, small couture line accessories, beyond the suit, may be eligible for the warranty policy and the return policy. Large accessories are not eligible. Please email customer service for approval.
- Once your egift card is received for a return, AC Bikinis does not guarantee there will be enough time to re-order and remake your couture suit if you wish to reorder a Couture line item. All e-gift cards can be used for any other competition suit or item purchase.
- **Disclaimer: Couture suits are intricately handcrafted and the finished product may have small variances from what is pictured on the website. All suits and accessories are produced with the customer's preference and designer's artistic discretion. Customers accept design concepts on their own accord.**

Production Turnaround Policy For New Order

All orders will be processed and fulfilled in a timely manner to make sure you have your full order in time for the Fashion Show. Due to the time sensitivity of the orders, it is important to make sure you are confident in your order selections and selected shipping method. The standard production turnaround for Angel Fashion Show orders will be determined and communicated to you when you place your order. It

may not be the same as the standard production turnaround for non Angel Fashion Show orders. Expected shipping dates are subject to change if a Production Order Change has been requested. Such production order changes may result in needing to upgrade shipping methods. AC Bikinis is not responsible if a suit does not arrive on time, even if AC Bikinis is aware of your show date. In most urgent cases, we will recommend upgrading to expedited shipping, but if you do not pay for the change, your order will be shipped according to the method selected on the order form. For specific questions or help deciding if you have enough time before your show, please email your suit specialist. If you do not have a suit specialist, please email customerservice@acbikinis.com.

Alterations to a Completed Suit

In the event your Angel Fashion Show suits do not fit, we will work with you to make sure they fit appropriately for the Angel Fashion Show. Depending on when you placed your order, you may have time to submit a Return to Reorder the full suit or send your suit back for adjustments. In most cases, we will be able to adjust your suit on site at the Angel Fashion Show. If you need a suit adjusted after a show, please contact customerservice@acbikinis.com. Suits may not be given to AC Bikinis personnel. All suits must be shipped to AC Bikinis and the appropriate order form placed for the alteration needing completed. All return shipping is the customer's responsibility to coordinate or you may use the Redo Shipping option on our website.

To ensure the safety and health of our sewing team, please thoroughly clean your suit before sending it back for your alteration. If received in an unclean or unsanitary state, you will be charged a \$30 fee before your alteration is completed. Thank you for your understanding

Order Changes After the Order Has Been Placed

All orders will be confirmed with a Confirmation Email. Please make sure to review this immediately for any potential errors. Your order can be processed into production within 24 hours of receiving your order. It is very important that you are 100% confident in the selections you submit to us as it is not easy for us to start over or make changes. However, if you would like to make a change to the design, color, size, or bottom cut, we can do a change for a \$30.00 fee. Changes in design can result in an increase in price and require starting over on your suit production. Please note that every decision we make is with the athlete in mind. When we have to interrupt the workflow of one customer's suit, it can slow down our entire process for all customers. We will do our very best to fulfill your change request within your selected production turnaround time.

If you are changing your crystal design, we will send an invoice for the price difference. We will not proceed with your change until the invoice has been paid.

Pre-owned Encore Suits and Accessories

All Pre-owned Encore suits and accessories are inspected and cleaned to provide the best possible condition for the suit being purchased. All suits are cleaned with clorox non-bleach wipes and inspected for any flaws. If the flaw does not affect the overall appearance and fit for the suit, it will be available for purchase. Fabric stains, custom sizes, and year version of the suit will be provided if known. Pre-owned Encore Suits are covered under the warranty policy for connector replacements and connector adjustments, and minor crystal repairs.

Pre-owned Encore products are FINAL SALE, unless the RENTAL option is selected at the time the order is submitted. If the option for rental use is selected on the order form, a return shipping label will be included with your order. Please email customerservice@acbikinis.com to notify Angel Competition Bikinis of your Intent-To-Return. Qualifying orders may be returned for a **60% store credit refund** sent via email or **40% payment method refund**. All refunds will be calculated according to the AFS package discount received on the original order.. Items must be received back within 7 days of receiving your Intent-To-Return. The total amount issued will not include the cost of the selected shipping method on the original order. Please make sure to retain all padding options, angel cases, and other purchased accessories. Any items returned other than the suit may not be returned back to the customer. Store credits and payment method refunds will not be issued until the suit is returned.

PLEASE NOTE: A \$30.00 cleaning fee will be automatically deducted from your suit return amount if the suit has any signs of wear, tanning residue, bodily residue. This will not be negotiated and will be determined at AC Bikinis' discretion.

Suit and Accessories Rental Policy

Currently only eligible on Pre-owned Encore, and Ready to Ship items. See Policy details under the Pre-owned Encore section. The rental option is ideal for shows in 30 days or less.

All items will be purchased at the listed MSRP with any applicable discount codes at time of purchase.

The Rental option must be selected on the order form. All rental returns must be received by AC Bikinis within 45 days of receiving your suit. A return shipping label for the *basic delivery option* will be provided with your order. Suits and accessories must be cleaned before returning. All items will be inspected upon return and a \$30.00 cleaning fee will be applied to any refund option if there are signs of wear, tanning residue, bodily residue beyond an acceptable level deemed appropriate by AC Bikinis.

Early Payments and Unpaid Balances.

AC Bikinis does not offer a payment plan. By approval only, customers may be allowed to submit early payments towards a future order. This is self-managed and installments will not be scheduled or requested by the company.

If an order is placed and a balance is owed, the order will be placed on hold at customer service and will not be started until full payment has been received. In most cases, an invoice will be emailed to you for the amount due. Then, your order will be placed into production according to the selected turnaround time from the day full payment is received.

Onsite Event Booth Sales

All transactions are FINAL SALE. If a suit purchase is needing a connector change or adjustment that is not available on site, it is the customer's responsibility to return the suit to AC Bikinis Headquarters and place a corresponding item return order. All shipping costs are the customer's responsibility. All Suit orders are eligible for the 365 day warranty policy. Please contact customerservice@acbikinis.com for return and ordering instructions.

Domestic and International Shipping Policy and Changes after the order has been placed

We understand the importance of having your suit delivered on time for the Angel Fashion Show. Again, we recommend ordering your suit at least 12 weeks out from your show. We do not recommend changing

your shipping address or shipping method within 72 hours of your anticipated shipping date. Please be confident that both the shipping address and shipping method you chose is correct.

AC Bikinis does not recommend shipping to Air BnB's or Vacation Rentals. AC Bikinis is not responsible for lost or stolen packages if your address is considered a vacation rental. We will ship to hotel addresses for Monday through Friday delivery. For orders expected to ship on Friday, Next Day Air shipping is available only to hotels that accept Saturday Delivery. Any late deliveries requiring a package to be re-shipped to a customer's address, will be the responsibility of the customer to coordinate with the hotel.

Please take into consideration both the production turnaround time you selected on your order form and your shipping method you selected during checkout. AC Bikinis is not responsible for suits not delivered on time if you selected the wrong turnaround or shipping method, even if AC Bikinis is aware of your show date. In most urgent cases, we will recommend upgrading to expedited shipping, but if you do not pay for the change, your order will be shipped according to the method selected on the order form.

Domestic and International shipping will be calculated upon checkout. We offer shipping via USPS, UPS, and FedEx. Please note that the shipping method you select only applies to the delivery time (from when we ship your package to when it is estimated to be delivered) and does not include the turnaround time to produce your order. Once we've shipped your order, you will receive an email with the tracking information and details to track the progress of your package. Once your package has left our building, ACB is not able to control any shipping delays. Please contact us should you believe that your package has been lost or stolen; We will try our best to rectify the situation if that is the case. However, if your show is less than 72 hours, AC Bikinis will not be able to recover your suit in time for your show.

ACB is not able to make changes to your shipping details once it has left the building. Please reach out to the carrier should you need to redirect or update your shipping address:

This warranty includes crystal replacements and connector replacement and resizing. This warranty does not include lost or stolen items, suit remakes or replacements, spray tan stains, connector changes, or suits purchased second hand. You must be the original purchaser. Please email your suit specialist for warranty qualifications.

In the unlikely event a stage or production malfunction occurs, we will make sure to appropriately rectify the situation for you. AC Bikinis does not offer refunds, reimbursements, or returns for any unworn or used Angel Fashion Show package items.
