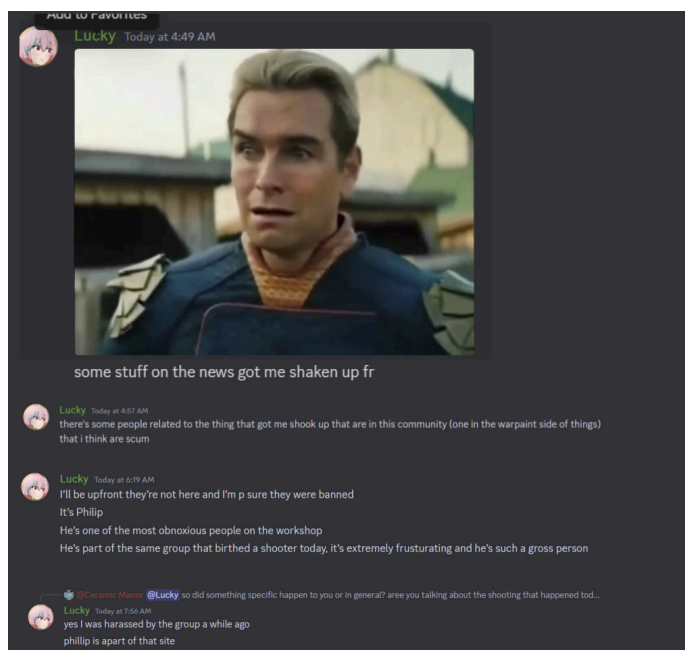
This will be a brief document that responds to information from Offshore:

Not only this, but days prior on 5/31/25 Opera communicated with Phillip, who claimed users of the TF2 Emporium organized the harassment with chickenman, he stated that there was an individual who had come out and stated as such, when asked for evidence he would state that he can not give evidence at this time, not only this but consistently through this Phillip would attempt to drag Offshore by connecting it directly with the TF2 Emporium which the two projects are separate and unrelated to.

It is not wise to reveal any Emporium informants who were staunchly against harassment. The simple statement that Offshore is “not affiliated” with the Emporium is meaningless, given the influence Emporium members had over creator participation, as well as clear neglect in situations concerning dozens of Emporium members.

Chickenman would be let back into the server while the team investigated further, this would lead to Phillip directly insulting and harassing Operabay, and going on a tangent about Emporium and claiming that Offshore was culpable for any actions that happened to him outside the server.

This fails to mention that Operabay prior to this leaked the identities of two primary whistleblowers and several others who were investigating the situation. As the investigation deals with harassment under large workshop circles, this is particularly irresponsible. Of course, John would be reasonably upset by this, especially at the notion of forwarding the screenshots to someone who tried framing him earlier this year for - supposedly - being part of a group affiliated with a recent school shooting and various doxxing incidents. This claim is untrue, and without intervention, could have resulted in dangerous consequences.



During this Razoldon (and by extent Phillip) refused to share information with some members of our moderation team such as certain screenshots or individuals involved in the situation, the specific reason is due to disliking those moderators/being told by people not to share with them.

The reason is that at the time, we didn't want to jeopardize the investigation. As if we shared everything too soon and spread it amongst the moderation team, leaks could have happened

and people could have clammed up and covered their tracks. This indeed happened anyways as Operabay leaked a screenshot to Chickenman, which was enough for him to cover his tracks.

This then prompted Raz to insult and belittle both the offshore project as well as Operabay for making the announcement and not apologizing or tackling the issue head on. Consistently threatening Opera with “going public” and pressuring him into making a formal statement despite investigations ongoing behind the scenes. The moderation team would apologize to Raz for the lack of transparency. He would also consistently threaten Opera with Zesty Jesus making a video on the server. Please note how Raz consistently refers to a group using phrases such as “we”. Raz also states that chickenman may not be the sole ringleader unlike what his video claims to state.

This is exaggerated. While I admit that later I got too aggressive out of frustration, the intention was not to harass anyone. I wanted to hash things out privately, as I didn't want the Offshore project to receive bad PR. As for Zesty, I never was using him as leverage, I was merely informing Opera that he knows about the situation, and that I was ultimately being consulted during all of this. As for Chickenman, this is a conflict of information, as we never implied he was the sole “ringleader” in all of this. (See Tab 2)

Raz then changes the terms we figured were okay with how we proceed in punishing chickenman as well as how we will handle members.

The reason why I was no longer okay with the terms stems from frustration over the inaction and disregard for the evidence provided. Despite everything, they decided to shield Chickenman citing “a lack of evidence”.

We then discuss further in depth about Hopkins and chickenman, I do not feel the need to post these but can if asked. I directly asked chickenman to apologize and clarify the situation to Raz directly. Raz agreed but then changed his mind several times, he states that he no longer wants involvement in the situation and to be kept out.

I never changed my mind “several times” nor did I agree to an apology from chickenman. This statement was clearly made to make me seem like I was flip flopping around the situation with the intent of discrediting me.

The Trailer was posted, the discord holds a watch party event. This leads to Raz spamming the map trailer as well as the reddit posts made referring to himself in the third person. He claims that Riverport was cut out by the Offshore team. This is completely and 100% false, and he was aware as such when being told.

I did not spam the map trailer with any comments. I left two, as shown in the document. As for what I meant by “cut out of the project”, it was for the website. This was caused by a collaborator who went behind the team’s back and told Operabay, without consulting me on the matter. This means that the map was mostly cut from the project, only remaining in the steam collection.

Raz then claims he wanted to be on the website

I never claimed I wanted the map on the website after it went public; I had, however, asked prior if it was still scheduled to appear. When I learned that a project member opposed featuring it, I realized it was never going to be included, which led me to say I was over it out of resignation. Ultimately, I was upset that I never had a chance to advocate for its inclusion.

He primarily talks about how Emporium has a history with these types of attacks, he states that other workshopers have told “us” of such, and still does not provide evidence. ^I've omitted screenshots regarding past Emporium issues and conflicts to not involve the victims of those circumstances who faced harassment from Emporium members at that time.

Stating that evidence was not provided, yet omitting screenshots of the matter is illogical.

To conclude/Quick TLDR:

While we have heavily not condoned the harassment against Raz and the Riverport team, condemning those involved and actively punishing those involved as well, there has been a lot of slander and omitted information on behalf of the Offshore team due to the negligence of Raz and those involved who have dragged Offshore through an otherwise unnecessary drama for attention and views. Originally it was planned to keep this and not involve individuals further, but we felt this needed to be addressed after it caused infighting between users in the discord server. Raz's (and party's) negligence on the situation, has led to a lot of misinformation being spread about us as a team and the project as a whole which has led to many users (some not even involved or aware of this!) to be harassed, especially from one sided rumors.

This document was made in bad faith. There is no evidence provided that supports that this was done for attention, views, or likewise. There was never any negligence on our part, and it's clear this document is passing the buck in terms of blame to us. After all, who was the one who leaked whistleblower information and needlessly escalated the incident to the public eye?

As for harassment that has occurred to project leads, I'm sorry you guys had to deal with this, but it has been stated multiple times that I do not condone harassment in any way.

Responding to Tab 2:

1. Chickenman's story was consistent across the board after being interrogated/messed by various people on and outside the offshore project
2. Hopkins directly lied about chickenman's role in the harassment campaign as an orchestrator of it despite not being true.
3. We believed that this was an organized campaign against chickenman using the harassment of riverport as leeway in order to target him directly due to the coordination between users and third party involvement, in part due to Zesty Jesus (will be explained in a later part).
4. There was no direct evidence of chickenman rallying people to harass raz.
5. There were red flags to us on the Offshore team especially later, such as withheld information about groups such as the Brazilian TF2 community as well as the level involvement of Hopkins.
6. We felt that disliking a map, criticizing a map, or sending an emoji to a map negative or not would constitute a can of worms which would result in several users being banned/being able to be reported for similar actions.
7. Both Raz as well as Phillip have directly stated that they're unsure fully if Chickenman was the leader of the harassment campaign.
8. We don't believe in guilty by association, people having connections to other groups or people does not mean that they are guilty.

1. This level of "consistency" in his story was never made known to me or anyone else aside from a few snippets. Regardless, the level of "consistency" is entirely up to subjective interpretation and may be easily manipulated. Hence, it is not a logical way to determine guilt - a person could be consistent with a lie, after all.

2. When he said he was "lying", he did not imply that everything he said was false, just the notion that he 100% knew who started the harassment campaign. This we already knew. However, the crux of the accusations stemmed from the screenshot evidence verified as true by Offshore staff, and from Chickenman himself. This was something the Offshore staff were given ample of, alongside context.

Yet this was never addressed here or anywhere else.

3. This is a ridiculous conjecture that is not based on any verifiable evidence. The investigation proceeded before people knew about his involvement. Only when sufficient evidence was made known was he the main target of the investigation. The notion that there were altercations between the whistleblowers and the accused is irrelevant to the case.

4. Ample screenshot testimonies with context were provided, yet were ignored by Offshore staff. **New whistleblower testimony (see below)** corroborates with existing evidence, analysis, and whistleblower testimonies. This should be an open and shut case now, though the evidence was plainly obvious before this.

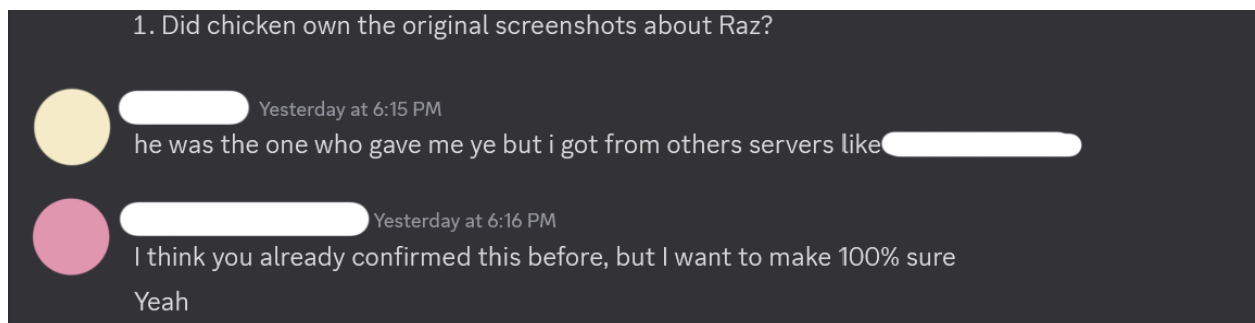
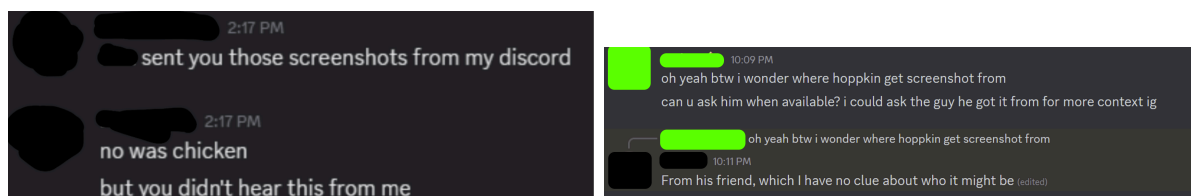
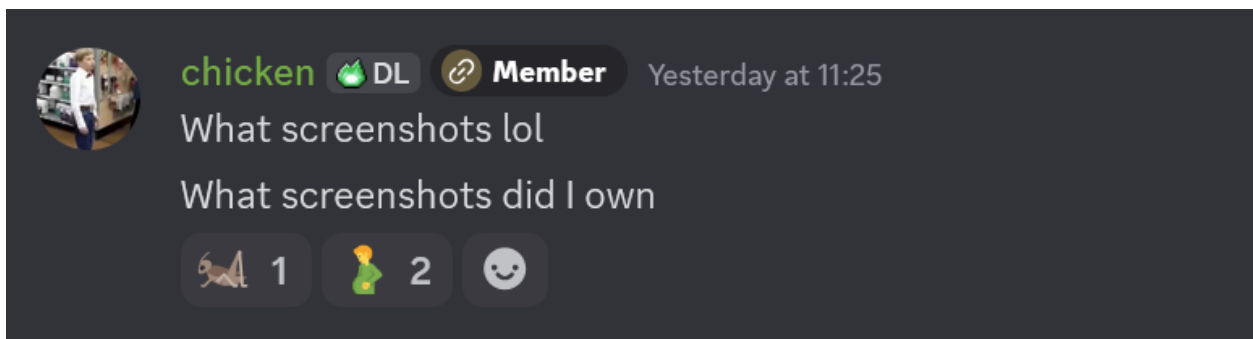
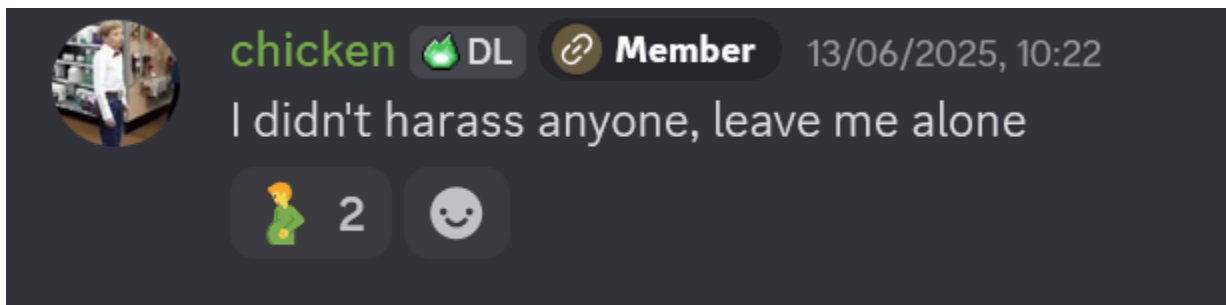
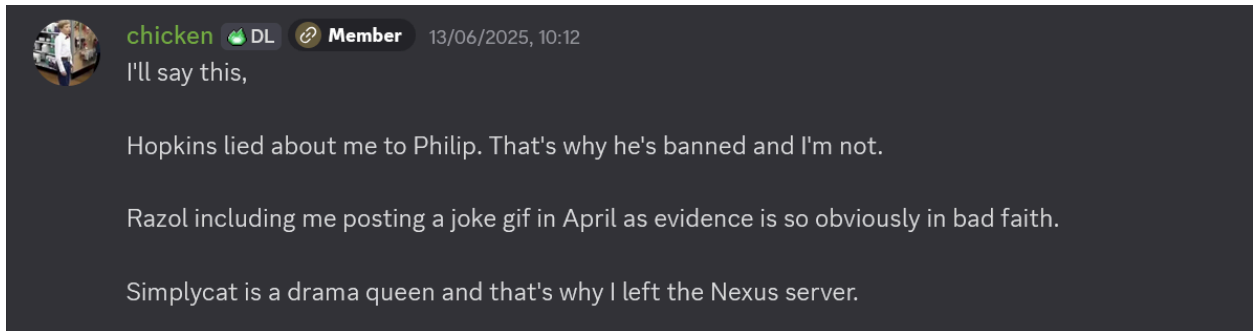
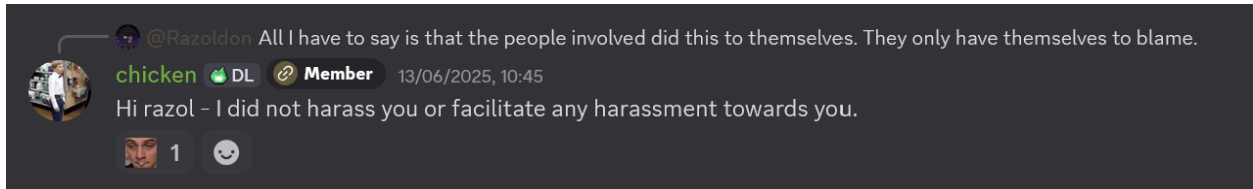

5. The involvement by the Brazilian TF2 community and Hoppkins was made known prior to Operabay. In terms of the investigation however, they only played a small role in the harassment, with ~7-8 people involved compared to the ~50 prior to 5/27. Likewise, amends were being made behind the scenes. Further information was also left confidential for the sake of whistleblower protection - which was violated with Offshore Lead Operabay's negligence.
6. The basis for this accusation was not a matter of simply "disliking" a map. No, this was an investigation into a mass downvoting and harassment campaign among multiple people of influence. This is a ridiculous slippery slope argument that demonstrates a lack

of care by Offshore staff on what this case is about and intention to dismiss the case under false pretense.

7. Incorrect. While there were other possibilities discussed to further the conversation with Offshore staff, the evidence still pointed to two people at fault. Evidence was consistently provided to support fault on Chickenman over the other party, such as testimonies by two whistleblowers that confirmed he sent the screenshots, yet this evidence was ignored.

So here's what we have so far.

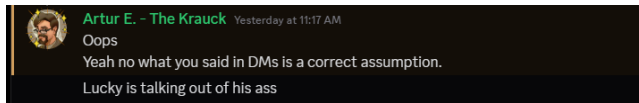
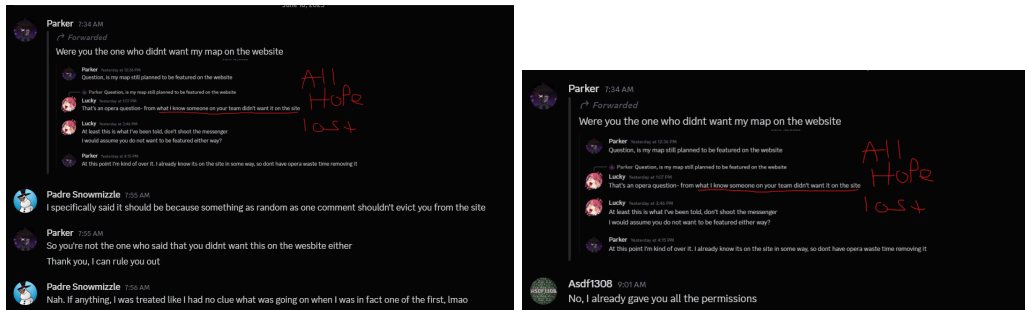
1. Chickenman sent screenshots of himself celebrating the first award given, and kept track of them within the span of minutes, hours, and days later.
 - a. This counteracts the claim that he simply "came across the map" randomly, and "decided to celebrate" for no apparent reason. Why would he celebrate the harassment of a map he wasn't aware of?
 - b. It is unreasonable that Chickenman would hold such resentment towards the map and creator, yet somehow was unaffiliated/didn't know about the several dozen other people in his primary community who were involved in harassing the map on 5/25.
2. Chickenman admitted to clowning the map.
3. Chickenman was the one that had possession of the screenshots and disseminated them to multiple whistleblowers. This was evident in the original analysis as well
4. Emporium whistleblowers stated that **Chickenman explicitly told them** to clown on the workshop map.

With Chickenman's activity beginning before the first wave of harassment, this heavily suggests that Chickenman was the one to first start attacking Raz's map. The evidence also heavily suggests that he was responsible for encouraging/riling several Emporium members to participate from 5/25 - 5/27.

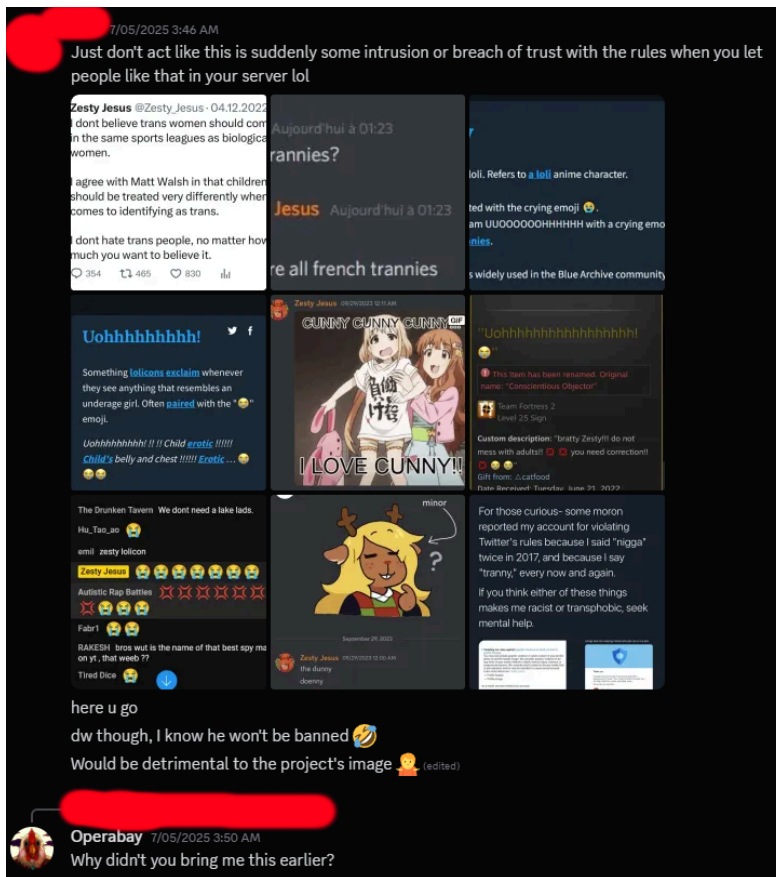
Why was riverport not included on the website?

It was if it would and would not be included. Raz then pressured and claimed Lucky to be lying, which Lucky would then release the user's name. The reason why Raz was kept unaware is to make sure the user would not be harassed by Raz. We felt that after the situation further it would not be due to the discretion of Offshore but members on the team of Riverport not wanting to associate themselves with the drama/Raz's past comments. Riverport was back and forth make sense to have Riverport be added as well when it was escalated.

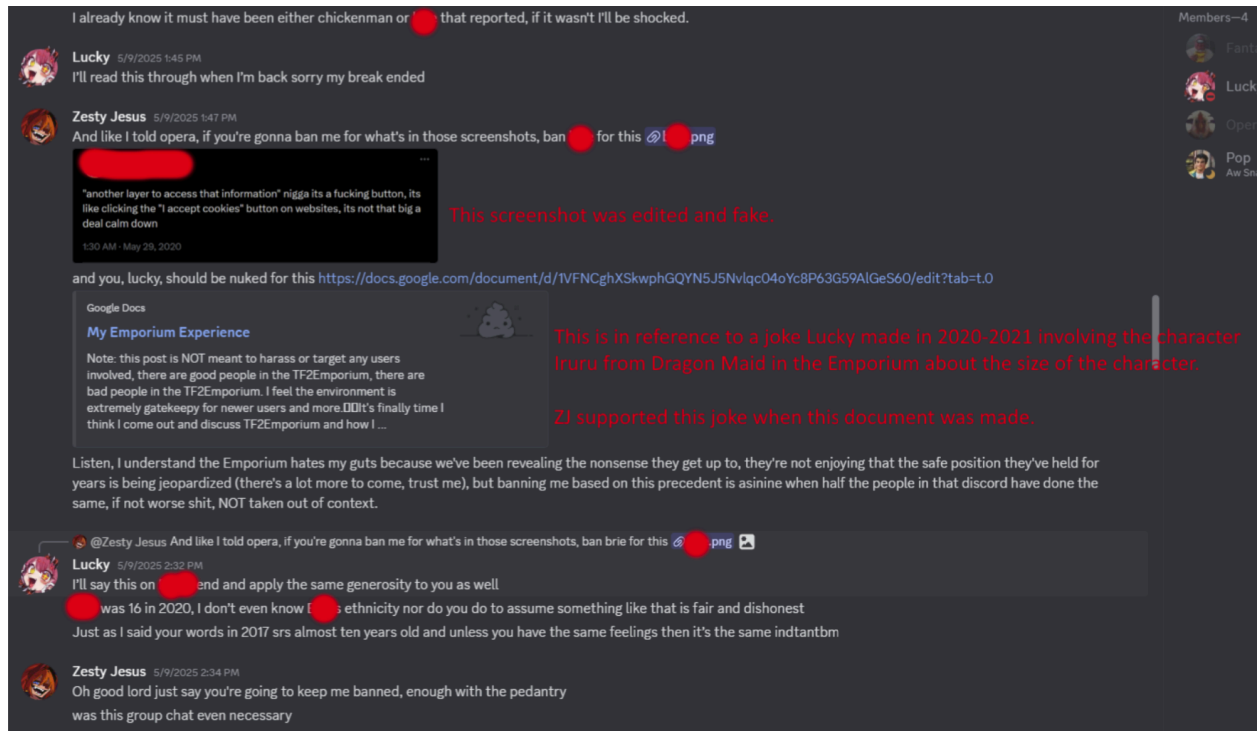
This is because Lucky withheld information on who did this, and all map team members denied involvement. As for "ensuring this member wouldn't be harassed by me", this is a slanderous conjecture that is not based on any verifiable information. If this was made known to me prior, the situation would not have escalated to such a degree now. Ergo, the responsibility again lies on the Offshore staff for not being transparent during the investigation.

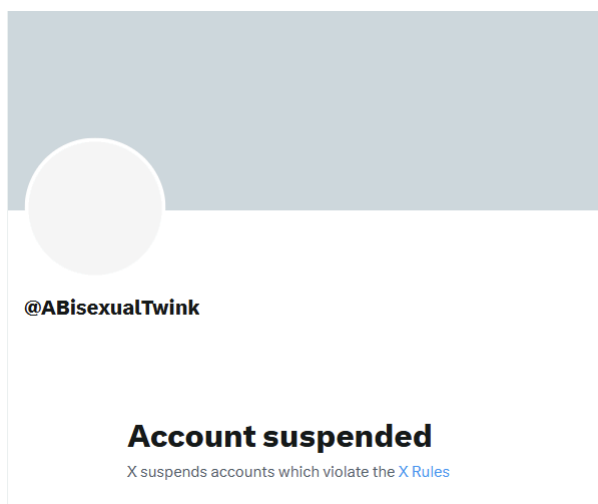

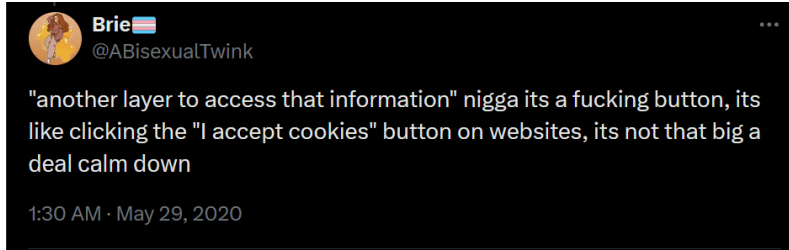

I recreated the photo that was posted. Was it an out of touch joke? Maybe? It's quite sad that *this* out of all things is the main takeaway is the "iruru" situation instead of the consistent harassment and mistreatment I faced in general in Emporium

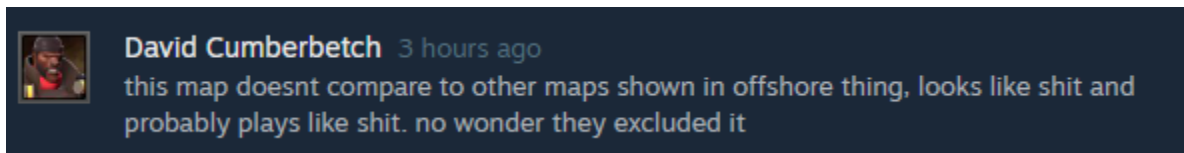
