The Executive Act

Whereas; The President has many responsibilities to handle on their own, and as a result is often overwhelmed.

Whereas; They require an assistant of sorts to ease the workload.

The following act is established.

Article One: Chief of Staff

- §1. The position of "Chief of Staff" shall be a position in the *Executive Branch* appointed by the President.
- §2. The appointment of the Chief of Staff shall not be subject to senate approval.
- §3. The Chief of Staff may perform some of the duties of the President upon the President's order or permission.
- §4. These duties include, but are not limited to:
 - Correspondence with members of government.
 - Correspondence with foreign powers.
 - Mediating disputes and issues between members of government.
 - Stepping in for the President during meetings or briefings.
- §5. The Chief of Staff may also act as an advisor for the President.
- §6. The Chief of Staff may be temporarily or permanently (until the end of the President's term) be given any security clearance for use in completing their duties and or assignments given by the President.

- §7. The Chief of Staff may deliver or write memos to any government agency or body on the orders of the President.
- §8. The Chief of Staff is restricted from holding the following positions:
 - President
 - Vice President
 - Speaker of the Senate
 - Senator
 - Supreme Court Justice
 - Judge
 - SoE
 - Press Secretary
 - Any position in the SimDemocracy Security Department or its sub departments.

Article Two: Press Secretary

- §1. The position of "Press Secretary" shall be a position in the *Executive Branch* appointed by the President.
- §2. The appointment of Press Secretary shall not be subject to senate approval.
- §3. The Press Secretary shall be the primary means of correspondence between the Executive Branch and the press.
- §3. The Press Secretary may call "Press Conferences" where they may speak to the press on important issues, take questions, or make statements.
- §4. The Press Secretary may do this on the orders of the President or the Chief of Staff
- §5. The Press Secretary is restricted from holding the following positions:

- President
- Vice President
- Speaker of the Senate
- Senator
- Supreme Court Justice
- Judge
- SoE
- Chief of Staff
- Any position in the SimDemocracy Security Department or its sub departments.

Article Three: The Cabinet

- §1. The Cabinet shall be a body containing the following members:
 - The President
 - The Director of Investigation
 - The Director of Reconnaissance
 - The Attorney General
 - The Secretary of Foreign Affairs
 - The Secretary of Expansion

Article Four: The Executive Category

- §1. There shall be a category on the discord known as "Executive".
- §2. This category shall contain the following channels, as well as any other channels requested by the President:
 - "The Office", the President's office, to be used as they choose.
 - "Cabinet Room", to be used for Cabinet Meetings.

- "Podium", for the Press Secretary, President, or Chief of Staff to conduct Press Conferences.
- "Press Room", For the press to ask questions during Press Conferences.
- "Spare Room", a spare channel, to be used for whatever purposes necessary.
- "Watercooler", a channel for casual discussion between any executive employees.

§3. The following roles will have access to the following channels:

- "The Office", The President and Chief of Staff will have access to this channel at all times, a role must also be created that may be applied to anyone at any time by the President, which allows access to the channel.
- "Cabinet Room" all members of Cabinet, as well as the Chief of Staff, should have access.
- "Podium" The President, Press Secretary, and Chief of Staff should be able to speak in this channel, a role should be created, which can be applied to anyone at any time by the President, which gives speaking permissions on the channel. The role "Certified Press" should be able to view this channel.
- "Press Room", should be able to be viewed by the President, Chief of Staff, and the role that allows access to the channel "Podium". "Certified Press" should be the only role permitted to speak in this channel.
- "Spare Room" should be able to be accessed by the President, a role which can be applied to anyone at any time by the President should also have access to this room.
- "Watercooler" should be able to be accessed by The President, Chief of Staff, Press Secretary, Cabinet, and any other executive officials who the President requests have access to it.
