Procedures

1. Immediate Concerns

- 1.1. Propose concern
- 1.2. Discuss concerns
- 1.3. Repeat 1.1–1.2 until all concerns have been addressed
- 1.4. Question period

2. Debrief (optional)

- ♦ This section is optional and only done upon request
 - 2.2. Full explanation of the mission and all components within
 - 2.3. Question period

3. Successes

- 3.1. Each participant is to give one mission related success they experienced
 - If a person has no successes, they may place themselves in "the neutral pile"
- 3.2. Question period

4. Failures

- "Live in the failure, acknowledge the failure, let the failure make you stronger"
 - 4.1. Each participant points out how a different person has failed
 - A person cannot be targeted more than once in the session. Only one failure per person. This is not a roast (roasts happen before missions)
 - While being accused, one may not issue any rebuttal
 - While being accused, one may not attempt to guilt the accuser
 - ⇒ If the accused attempts to guilt their accuser, the accuser is then granted a _____ veto
 - Tony and Tamlin are off limits
 - ⇒ They may criticize each other, but it must be in a stage whisper
 - 4.2. Question period

5. Mysteries

- 5.1. Any participant may propose a mystery
 - Clarifying questions allowed during any time
- 5.2. Other questions only allowed at the end of the segment

6. Desires

- ♦ "I desire"
 - 6.1. Each participant may propose their desires
 - 6.2. Question period

7. General Muckery

7.1. Put on the general muckery theme song

After Mission Meeting Procedures Page 2

- 7.2. The following are allowed in general muckery:
 - Lying
 - Fighting words
 - Mud slinging or slanging
- 7.3. Question period

8. Closing Ceremonies

- 8.1. Assign participant roles
 - Two participants must engage in the ceremonial sword fight
 - ⇒ Lightsaber sounds should be made when swords are "drawn"
 - One participant must be assigned to control of the lights
 - One participant may play the closing ceremony theme if a piano is available
- 8.2. The ceremonial sword fight should commence
 - During the ceremonial sword fight, the lights should flicker at a quick pace to invoke the feeling of tension
- 8.3. The closing poem is to be read over the closing ceremony sword fight. The closing poem is as follows:
 - I'd like the memory of me to be a happy one
 I'd like to leave an after-glow
 of smiles when life is done
 I'd like to leave an echo
 whispering softly down the ways
 of happy times and laughing times
 and bright and sunny days
 I'd like the tears of those who grieve to dry before the sun
 of happy memories that I leave
 when life is done

Two Minutes for Tea

Two Minutes for Tea may be called by any person at any time. During this time, all arguments are placed on hold for two minutes of calm.

"Two for tea, tea for two..."

- Camomile and other non-teas are not permitted
- Trick questions are permitted

Definitions

- Statements and "non-questions" (questions spoken as a statement) are legal during any time.
- Questions are only allowed during question times. The exclusion to this rule is during Mysteries as noted in 5.1, bullet 1, above.

Rules

- During meetings all participants must wear their meeting sports coat
- No one allowed to leave until session is complete.
