## Concessions: Desirae Monaco and Sandra Osbourne

- Sandra willing to help get us going for the fall season.
- Going to try and make some menu changes.
- Bulk ordering needs to be changed as we do not have the same storage as we did last year
- Joy and Rachael going to help clean the HS Stadium stand on 8/8/24 to prepare for the upcoming games.
- Still need new head of concession to help coordinate and order.
- Talk about bringing pizza to the middle school for when kids are hungry right after school and staying around until their event starts.
- Concessions made around \$30,000 last year so will discuss making this role a possible paid position.

#### **Old Business:**

- Hudl- Current membership is Silver and \$10,600. Teams pay \$5,000 and Booster pays \$5,600.
   Would like to upgrade to a gold which is \$14,000 or \$16,000 depending which gold level needed.
- The gold levels come with being able to assist in all teams and not just varsity. Have more cameras and would include a portable camera for away games.
- Will try and acquire more info such as how much the teams utilize this system to take a vote on the upgrade.

#### **New Business:**

- PA system in gym needs upgraded to work with the Neptune system we use for games.
   Hubbard music gave a quite of \$3582.60 to upgrade. Much better deal than replacing whole system. Will send a message to get a proxy vote on this.
- Will need a new Secretary and 4 new trustees for the upcoming school year. Vickie Paisley did an amazing job as secretary and will be missed. She is willing to help train anyone who takes the role.

- Snap Raise- If we commit to running 7 snap raise fundraisers in the school year they will give us a 90/10 split instead of an 80/20 split. Two teams have already committed to a snap raise this year.
- Next meeting we will be discussing a youth program and an activity coordinator position.
- Any new members interested in becoming a trustee or taking a position needs to attend next meeting.
- No stipends will be handed out to teams until the coach or Liason on that team comes to a meeting and picks up the Liason folder.
