17-80 Paving of a Private Street

The resurfacing of the private way known as Mt. Pleasant Street from School Street through its end (which abuts Nos. 15-17 and 19-21 Mount Pleasant Street) and that this area, being the private way known as Mt. Pleasant Street, be resurfaced in accordance with §§ 17-80 through 17-81 of the General Ordinances of the City of Waltham. Furthermore, a 6-8-foot passageway that extends from 11 Mount Pleasant to Liberty Street *shall not be repaved* as this area, which is not a private way, is not able to be repaved pursuant to §§ 17-80 through 17-81. Betterments shall be assessed. Assessments will be imposed on 6, 5-7 & 8 Mount Pleasant Street and 64 and 66 School Street on the basis of frontage and use whereas assessments will be imposed on 11, 15-17, 19-21, 23-25, and 27-29 Mount Pleasant Street based upon use only.
