Each paper must include an abstract. It is paragraph with normal 12-point font.

The design of an abstract as an independent source of information that provides a reference summary of the basic content and structure of the article is as follows:

- Text of an abstract must include: relevance of the research; method(s) or research methodology describe in cases where they differ originality or they are important in framework of this topic; empirical data sources and methods of data analysis indicate in applied articles; results according to the tasks (the main theoretical and applied results, the identified relationships and regularities; conclusions (may include recommendations, estimates, proposals, hypothesis etc.).

- Do not cite references in the abstract. Please do not place or cite tables and figures in the abstract either;

- The length of an abstract should be 150–200 words, or up to 1800 signs.

Keywords: Keywords up to 6 meaningful words / phrases are your own designated keywords separated by commas (“,”).

Begin the abstract with the Surname Name of authors (first author is corresponding author, other authors are in contribution order, or all authors are in alphabetical order) and article title in bold font, followed by a paragraph with normal 12-point font. Do not cite references in the abstract. Please do not place or cite tables and figures in the abstract either.

Keywords: Each paper must include Keywords in Ukrainian (Ключові слова:). Editors provide an appropriate translation in Ukrainian for foreign authors as needed.

FIRST LEVEL HEADING (HEAD 1)

The body text starts with a standard first-level heading like INTRODUCTION or any other heading suitable to the content and context (Scientific problem and the

relevance of the research, and its connection with important scientific or practical aims, etc.). First level headings are in all caps. Introduction is without number.

Headings should always be followed by text. Text should be with normal 14-point font (Times New Roman, 1.5-spaced).

References must be in APA style (<http://www.apastyle.org/learn/tutorials/basics-tutorial.aspx>). References should be clearly cited in the body of the text, e.g. (Ivanenko, 2018) or (Ivanenko, 2018, p. 16), or (Ivanenko, 2018; Salnikova, 2014, p. 15), or (Ivanenko, 2018a) and (Ivanenko, 2018b); the author's surname is indicated in the original source language.

1. FIRST LEVEL HEADING (N. HEAD 1)

Next first level headings are with number. You can make any number of selected parts of the article and title of headings, but in general they should present the purpose of the study, its methodology, main results, discussion and conclusions, and the heading should be suitable to the content and context.

These may be such heading: analysis of the latest / recent researches and publications, or theoretical framework, and methodology, and empirical database; research aim and tasks; main research material with validation of the received results; conclusions and outlooks for future researches in this field, etc.

1.1. Second Level Heading (Head 2)

The all FIRST LEVEL HEADING (N. HEAD 1) can be divided into some Second Level Heading (Head 2) and even third ones (you can use italics, but not underlines). The all Second Level Heading (Head 2) aren't in all caps.

1. FIGURES AND TABLES

Figures and tables should be inserted in the appropriate places in the text.

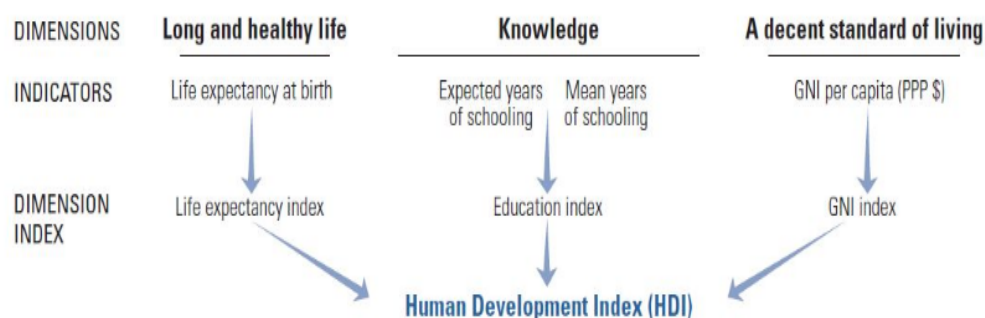


Fig. 1. *The structure of the Human Development Index (HDI),*

2. MATH AND EQUATIONS

ACKNOWLEDGMENTS

The title ACKNOWLEDGMENTS should be in all caps and should be placed above the references without number. The sources of funding of the research and article should be indicated (e.g. funds of the university / employer (name), or non-profit project, or grant / research project (name, number)).

At the end of the paper the author(s) should present full REFERENCES in the alphabetical order as follows:
