

EXPORT SUMMER PLAYGROUND PROGRAM:
RULES/GUIDELINES

****10:00 am – 1:00 pm****
Monday-Wednesday-Friday

1. All children must register for the program to be eligible for participation. At least two emergency contact numbers must be provided for each child. Emergency contacts must be an adult that is available during the hours of the program and has transportation in the event of an emergency.
2. Sign in on arrival and pick up is required. If someone else is picking up your child, please inform staff prior to pick up/drop off. They will need identification when they come to pick them up. A copy of a court order must be submitted if a parent or other individual is not permitted to pick up or have contact with your child.
3. Program hours are **10:00 am – 1:00 pm**. Do not expect supervision before or after those times. Please do not bring your child prior to 10 am. Playground staff uses this time to set up materials and get ready for the day. Also, please respect playground staff's schedules and pick your child up by 1:00 pm.
4. Children will need to bring their own lunch most days. Refrigeration is available. We will notify you in advance of any days we may be getting pizza, etc.
5. In case of injury, basic first aid will be given and emergency medical care if the injury is severe. We will attempt to call you and if necessary, the emergency contacts listed prior to calling an ambulance. However, if injuries are severe, an ambulance will be called and your child taken to the hospital. If your child is allergic to bees, please send in the appropriate bee sting remedy. It is recommended that children wear tennis shoes or closed shoes instead of flip flops for safety purposes.
6. Fighting, hitting, kicking, swearing, bullying and non-compliance with playground staff are not permitted.
FIRST OFFENSE = WARNING. SECOND OFFENSE = 1 WEEK SUSPENSION. THIRD OFFENSE = EXPELLED.
7. Children are permitted to bring their own toys, however, please make sure everything is clearly marked with child's name to ensure safe return. No metal or wooden bats and no toy guns (with the exception of squirt guns on hose days).
8. Please bring a water bottle marked with your child's name. Parents will be notified of "splashing with the hose" days so appropriate clothing, towels, etc. may be worn.
