

Conifer High School - DECA Conduct Code

We have many exciting and educational field trips planned for this coming school year. This Code of Conduct that must be adhered to during any DECA/Marketing conferences and field trips that students attend. These conferences come about only as a result of hard work. A positive or negative behavior is a reflection of you as an individual and Conifer High School in general. Students must be in good standing at Conifer High School in order to travel with DECA. Failing grades, suspensions or school behavior infractions may prohibit members from attending DECA trips. Students must demonstrate the ability to manage themselves appropriately at school prior to traveling with our DECA program.

Please read the following thoroughly and sign below.

- * No alcohol, drugs, juuls, vapes or tobacco allowed at any time.
- * Students are required to obey all posted curfew times and spend the night in their own assigned hotel room.
- * Students are required to attend all meetings as announced and on time.
- * Students will conduct themselves in a proper, businesslike manner at all times.
- * Lost room keys, room charges & property damage will be charged to individuals in that room.
- * Students must travel with the group; no personal automobiles or rides with other people unless pre-approved with Ms. Hall.
- * No students outside the conference should be within our DECA group, event or contingent.

Potential consequences are:

- Forfeiture of trip cost
- Being sent home from the conference and expenses associated with this infractions that warrant suspension (alcohol, drugs, harm to others) or breaking of curfew will automatically result in immediate dismissal from the trip
- Payment of damages
- Dismissal from DECA; forfeiture of the opportunity to letter
- Suspension (as determined by Administration)
- Other consequences the advisors deem appropriate

I (parent/guardian) also grant permission to the sponsors and chaperones to do what they judge necessary to control or modify any behavior by my son/daughter which they (sponsors) perceive as being harmful to the success of the trip and/ or discomforting to the other participants. If my son/daughter becomes a problem in any way, I will accept a call from the sponsors and with them consider a manner in which the problem will be promptly solved. This may include arranging for transportation of my son/daughter back to Conifer, whether it be from Beaver Creek, The Broadmoor, or Florida.

DECA TRAVEL ELIGIBILITY

DECA trips are a privilege, not an entitlement. To be eligible to participate in DECA trips, students must be in good behavioral and academic standing at Conifer High School and adhere to the DECA Code of Conduct. For all trips, any behavioral issues at school resulting in disciplinary action or suspension that demonstrate a pattern of poor choices at school, including the use of alcohol, tobacco, drugs, or behaviors such as bullying, insubordination, assault or ditching will results in students losing their opportunity to participate in DECA trips or competitions away from Conifer High School. Students on safety-plans or on the no-pass list may only travel if the Advisor in charge feels he or she can support the requirements of those plans. Eligibility for DECA trips will be additionally be determined based on the following guidelines:

SINGLE-DAY TRIPS:

- Students must be passing 4 or more of their Conifer High School classes at the time of registration and through the week leading up to the trip.
 - o No refunds will be granted to students who become ineligible after the payment commitment deadline.

<u>OVERNIGHT TRIPS WHERE STUDENTS MISS 1 SCHOOL DAY - EACH STUDENT MUST:</u>

- **be passing 4 or more classes** at Conifer High School at the time of registration and throughout the 2 weeks leading up to the trip
 - o No refunds will be granted to students who become ineligible after the payment commitment deadline.

<u>OVERNIGHT TRIPS WHERE STUDENTS WILL MISS 2 OR MORE DAYS OF SCHOOL - EACH STUDENT MUST:</u>

- have C- grades or better in 4 or more classes AND be passing all classes at Conifer
 High School at the time of registration and throughout the 2 weeks leading up to the trip
 - o No refunds will be granted to students who become ineligible after the payment commitment deadline.
 - Students who have behavior issues on a previous trip in the same school year are not eligible for additional DECA trips during that school year.
