Subject: Inclusion of Transpersons in Police recruitment

The Maharashtra Police recruitment process was recently implemented on behalf of the Home ministry Department of the Government of Maharashtra. In the said recruitment process, as part of the petition filed in the Hon'ble High Court, the Government of Maharashtra added the option for transgender person to apply. An order was given to the government by the Hon'ble High court to include this in the recruitment process.

As a part of the same process, written and field examinations were given by transgender candidates. And most of them have also qualified. But while publishing the result list, it is quite inappropriate for the said department to include transgender persons in the general category. If there was a separate column at the time of the application, then there should be a separate column for the result. Also, the Maharashtra government should think and plan about horizontal reservation.

We also had a positive discussion regarding this with the delegation of Maharashtra State Transgenders Rights Struggle Committee on Wednesday 12/04/2023 by way of protest. The department wise lists are being published and transgender candidates have been excluded from it. It is extremely discriminatory. A large neglected section of the so either looks up to you as a people's leader. We request you to deliver justice to the Transgender community.

विषय :- तृतीयपंथीयांना पोलिस भरतीमध्ये सामावून घेणेबाबत.

माननीय महाराष्ट्र शासनाचे गृहविभागाचे वतीने महापोलिसभरती प्रक्रिया नुकतीच राबविण्यात आली. सदर भरतीप्रक्रियेमध्ये, मा उच्च न्यायालयात दाखल याविषयाचे याचिकेच्या अंगाने, महाराष्ट्र शासनाने तृतीयपंथी हा पर्याय स्वतंत्र ठेवत भरतीप्रक्रियेत सामावून घेण्यासाठीचे आदेश शासनाला दिले होते.

त्याच प्रक्रियेचा भाग म्हणून लेखी व मैदानी प्रक्रिया तृतीयपंथी उमेदवारांनी दिल्या आहेत. व त्यातील बहुतांशी पात्र देखील झाले आहेत. परंतु निकालाची यादी लावत असतानां मात्र सदर विभागाने सर्वसाधारण श्रेणीत तृतीयपंथीयांचा समावेश करणे हे अगदी अयोग्य आहे. जर याविषयी उमेदवारी अर्जासाठी स्वतंत्र कॉलम केला आहे तर निकालासाठी पण स्वतंत्र श्रेणी असावी. तसेच होरिझेंटल रिझर्वेशन च्या अंगाने स्वतंत्र विचार महाराष्ट्र शासनाने करावा.

याविषयी आपणाकडे दिनांक १२/०४/०२३ बुधवार रोजी आंदोलनाच्या मार्गाने महाराष्ट्र राज्य तृतीयपंथी हक्क अधिकार संघर्ष समितीचे शिष्टमंडळासोबत आपण सकारात्मक चर्चा देखील केली होती. परंतु आता विभागनिहाय यादी येत असून त्यात एकही तृतीयपंथी उमेदवार पात्र नाही, असे करणे हे अन्यायकारक आहे. समाजातील एक मोठा दुर्लक्षित घटक आपणाकडे लोकनेता म्हणून पाहत आहे. त्याला आपण न्याय मिळवून द्यावा हि विनंती.
