**A RESOLUTION APPROVING THE BARANGAY ROAD CLEARING ACTION PLAN OF  
BARANGAY \_\_\_\_MUNICIPALITY OF \_\_\_\_PAMPANGA**

**WHEREAS**, Section 16. General Welfare. - Every local government unit shall exercise the powers expressly granted, those necessarily implied there from, as well as powers necessary, appropriate, or incidental for its efficient and effective governance, and those which are essential to the promotion of the general welfare. Within their respective territorial jurisdictions, local government units shall ensure and support, among other things, the preservation and enrichment of culture, promote health and safety, enhance the right of the people to a balanced ecology, encourage and support the development of appropriate and self-reliant scientific and technological capabilities, improve public morals, enhance economic prosperity and social justice, promote full employment among their residents, maintain peace and order, and preserve the comfort and convenience of their inhabitants.

**WHEREAS**, Section 17. Basic Services and Facilities - Local Government Units shall endeavor to be self-reliant and shall continue exercising the powers and discharging the duties and functions currently vested upon them. They shall also discharge the functions and responsibilities of national agencies and offices devolved to them pursuant to this Code. Local government units shall likewise exercise such other powers and discharge such other functions and responsibilities as are necessary, appropriate, or incidental to efficient and effective provision of the basic services and facilities enumerated herein. (b) Such basic services and facilities include, but are not limited to, the following:

(v) Maintenance of Barangay roads and bridges and water supply systems

**WHEREAS**, the Department of the Interior and Local Government (DILG) issued DILG MC No. 2024-053, which outlines the guidelines for the nationwide implementation of Barangay Road Clearing Operations, Assessment, Validation, and Recognition under the Bagong Pilipinas Campaign.

**WHEREAS**, under section 5.3.1.2 of DILG-MC 2024-053, all Sangguniang Barangay Members and other elected functionaries are directed to actively join their respective Punong Barangays during the conduct of Barangay Road Clearing Operations (BaRCO).

**WHEREAS**, Punong Barangay \_\_\_\_\_ issued Executive Order No. \_\_\_\_\_ series of 2024 constituting the Barangay Task Force Against Road Obstruction (BTFARO).

**WHEREAS**, Section \_\_\_\_ of the said Executive Order No. \_\_\_\_ series of 2024 enumerated the general duties of the BTFARO, which includes the following:

- (2) Formulate and implement Barangay Road Clearing Action Plan;
- (3) Implement Barangay Road Clearing Operations related ordinances and issuances

**WHEREAS**, the members of the BTFARO reviewed and unanimously approved the attached Barangay Road Clearing Action Plan.

Now, **THEREFORE**, be it resolved as it is hereby resolved to approve by the Sangguniang Barangay this resolution approving the Barangay Road Clearing Action Plan\_\_\_\_\_
