I, _____ ("Exhibitor/Participant"), voluntarily apply to participate in activities associated with the South Valley Agricultural Fair (SVAF), including but not limited to the exhibition, transportation, care, fitting, showing, sale, and handling of livestock, participation in contests and educational activities, and any other events conducted on or in conjunction with the South Valley Agricultural Fair.

I understand and acknowledge that livestock exhibitions and agricultural events involve inherent risks, including but not limited to:

- Animal behavior that may result in injury or property damage;
- Slips, trips, falls, or other accidents;
- Exposure to weather, equipment, vehicles, and agricultural facilities;
- Actions or negligence of other participants or spectators;
- Risks associated with loading, unloading, transporting, and caring for livestock.

I knowingly and voluntarily assume all risks of bodily injury, illness, death, property damage, or other loss arising from my participation, whether known or unknown, foreseeable or unforeseeable.

Release and Waiver of Liability

In consideration for being permitted to participate in the South Valley Agricultural Fair, I, on behalf of myself, my heirs, executors, administrators, assigns, personal representatives, and next of kin, hereby release, waive, discharge, and covenant not to sue:

- **South Valley Ag Fair, Its Board, Volunteers, Committee members, Judges, Sponsors, Host facilities, Property owners, Employees, Agents; and...**

Any affiliated organizations or individuals acting on behalf of SVAF from any and all liability, claims, demands, actions, causes of action, damages, costs, or expenses arising out of

or related to any injury, illness, death, loss, or property damage sustained while participating in or attending any SVAF event, except where prohibited by applicable law.

Responsibility of Exhibitors

I agree to abide by all rules, policies, and procedures outlined in the current South Valley Agricultural Fair Handbook and Official Rules, including any decisions made by the Board of Directors or designated officials. I understand that failure to comply with any rule may result in disciplinary action, including disqualification, forfeiture of awards or premiums, removal from the grounds, or suspension from future participation. I accept full responsibility for the care, supervision, conduct, and control of myself, my family members, guests, and my animals while participating in SVAF activities.

Medical Authorization (Minor Participants)

In the event of an emergency involving a participant under eighteen (18) years of age, and a parent or legal guardian cannot be reached, I authorize emergency medical treatment deemed necessary by licensed medical personnel. I understand that all expenses incurred are my responsibility.
