Your request for redo must be clearly formulated otherwise the designer can't apply your comments to the order.

If you wish to include additional retouching services (not present in the current order) in your redo request, please note that extra credits equivalent to the cost of each new retouching service will be deducted from your customer balance. If your desired service is not among the listed offerings in the application, the Custom Retouch Service will be applied.
