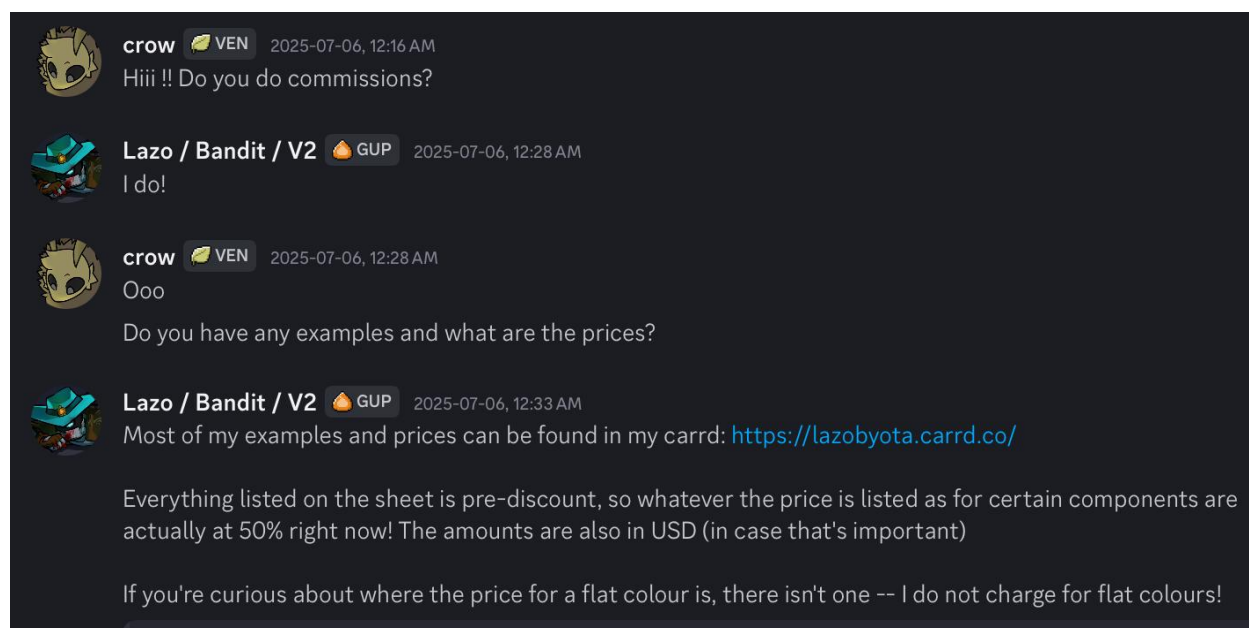

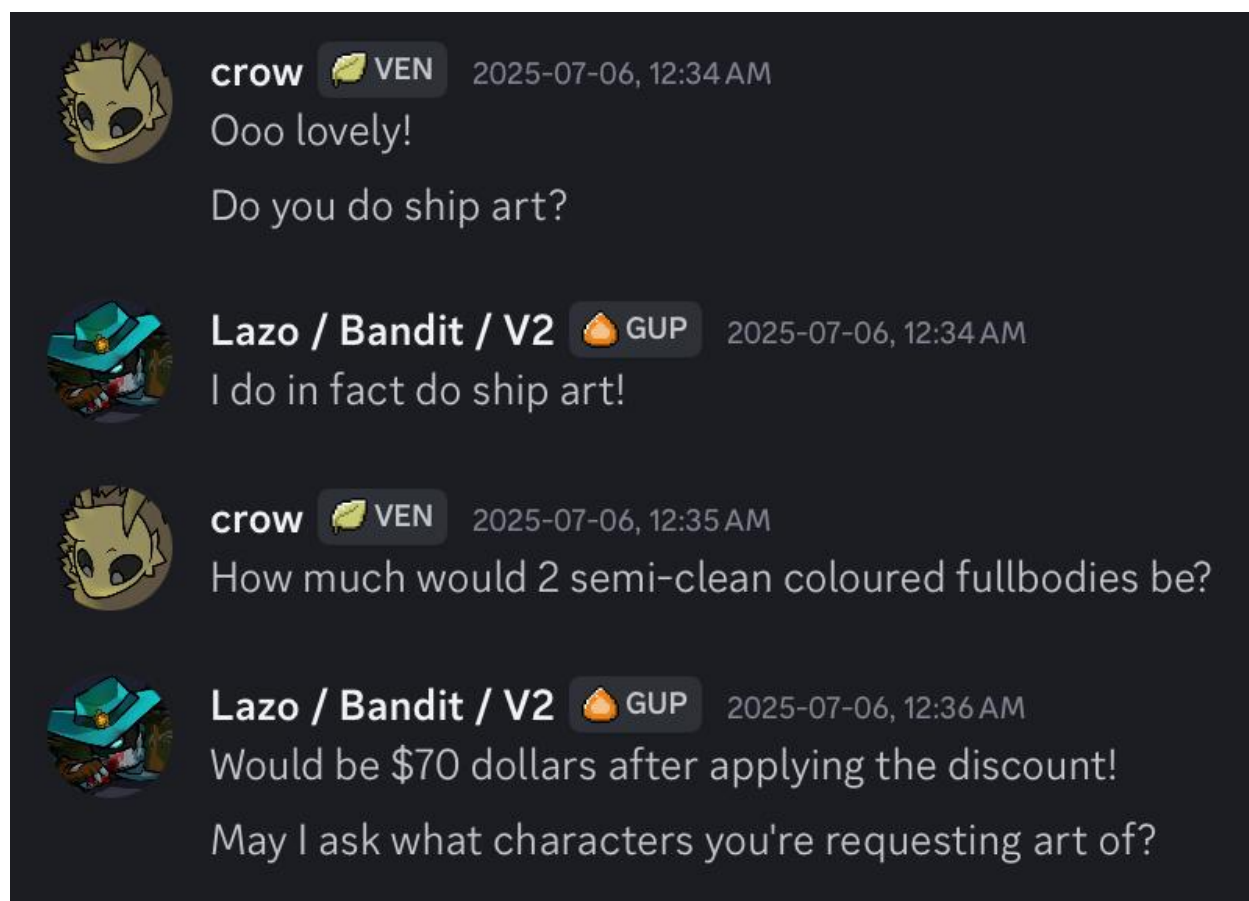


THE COMMISSION PROCESS

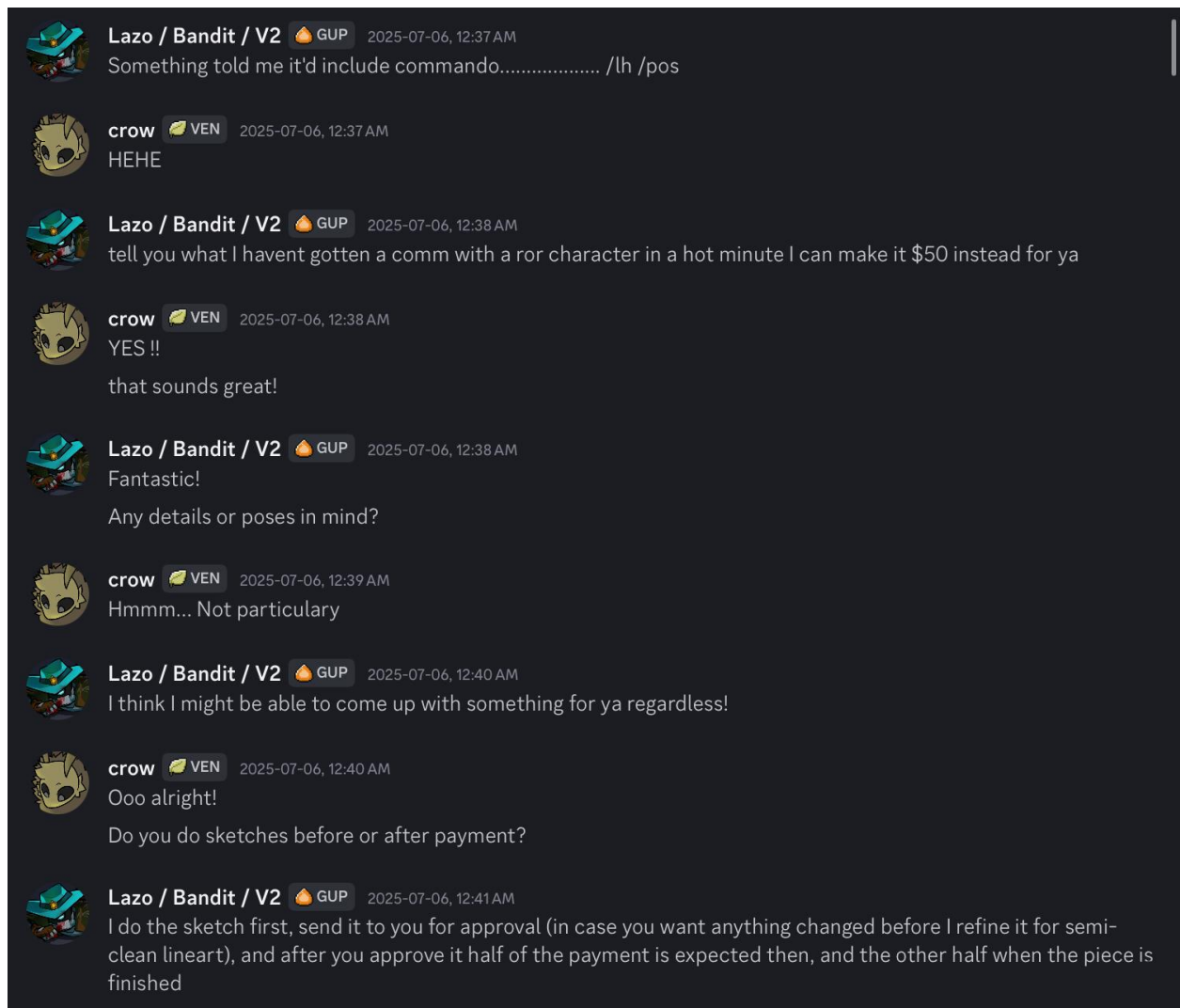
On July 6th, I contacted Lazo (he/it/hymn) about a commission.



I asked him if he could draw my sona, Ven, and Commando.

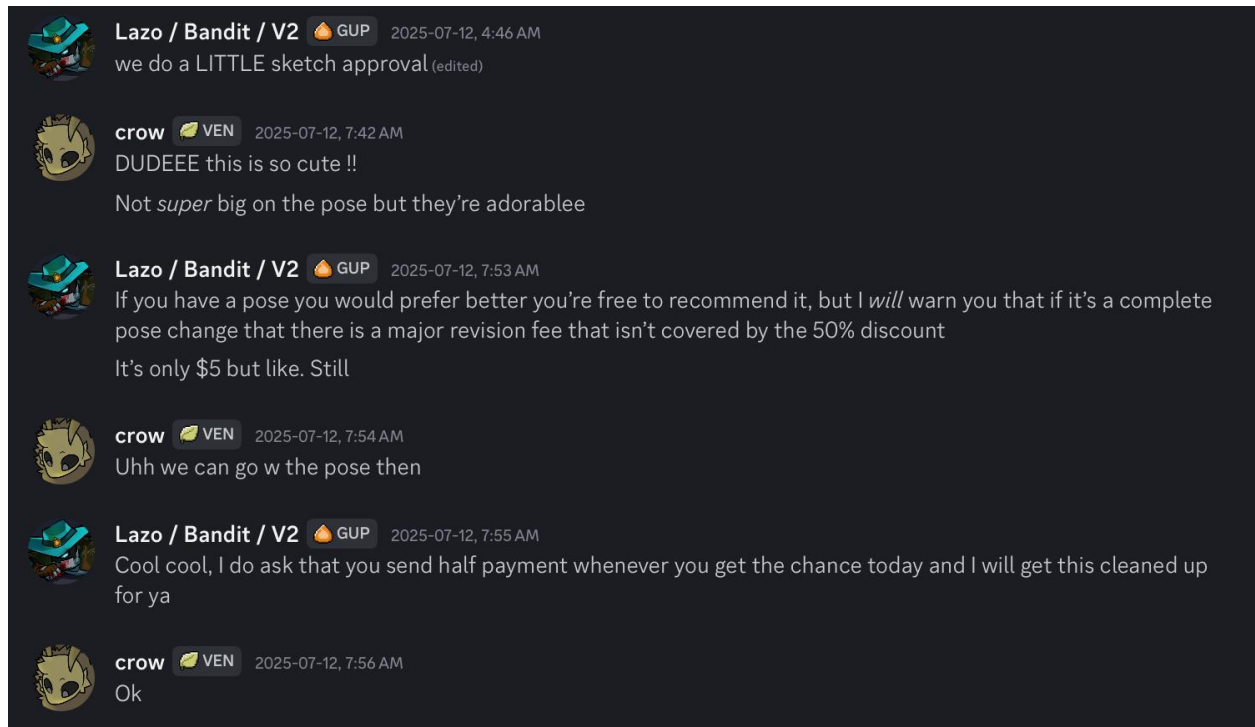


Lazo agrees to the commission and explains a bit of his process.



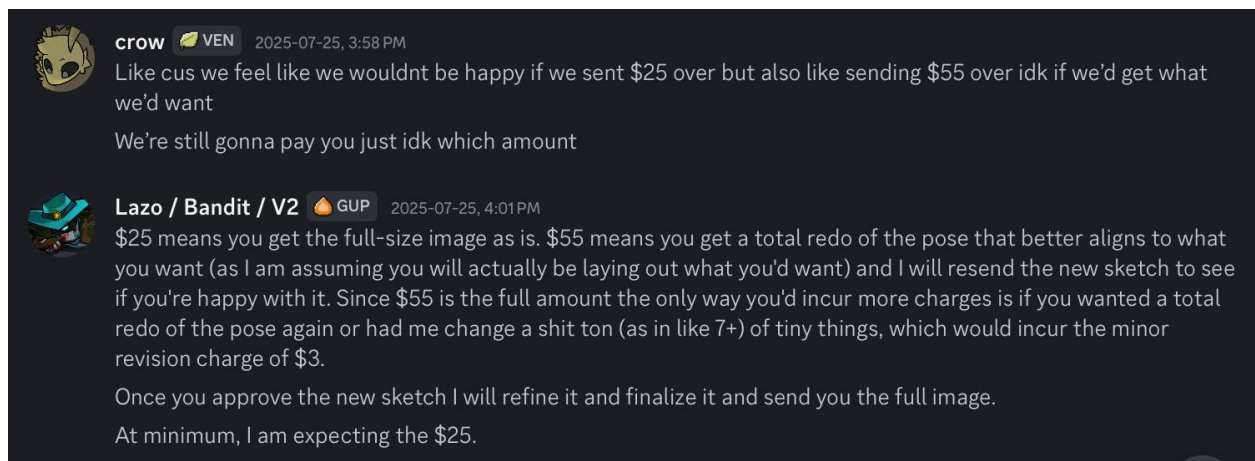
On July 12th, Lazo sends the sketch for approval. I'm not fully happy with the pose. It's fair, I didn't give him a specific pose.





NOTE: This part is my fault. I took several weeks to get back to him with the payment. I was pretty sick and Kofi wasn't accepting my payment method, so I had to directly Venmo him.

I paid him in full + the \$5 revision fee, so that was \$55.



After I paid in full and the revision fee, I sent him a pose reference. **This part is important.** Lazo accepts the commission and seems capable of drawing it.

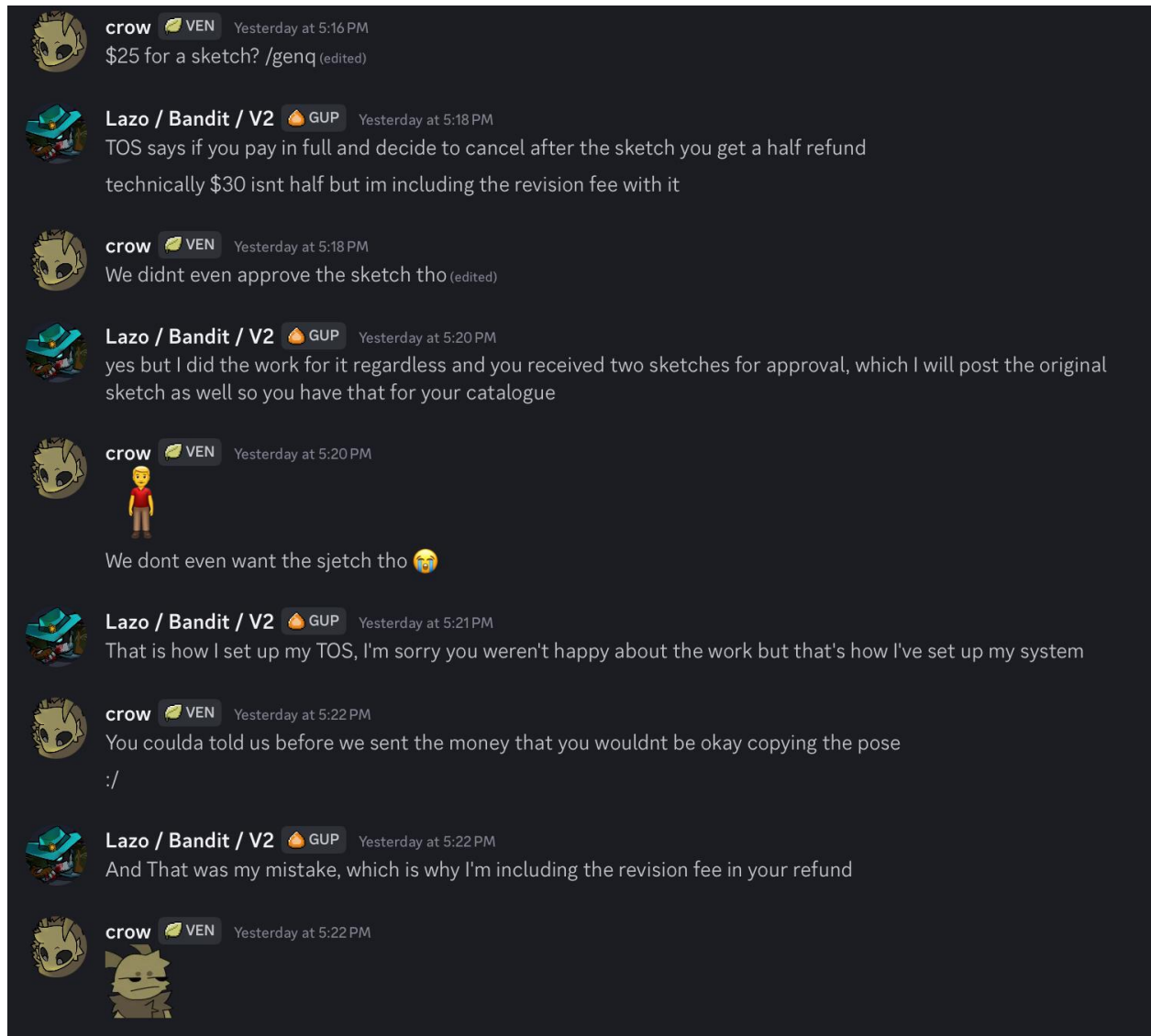

...until I checked his TOS.

4.2. Prior to receiving the finalized piece, the other half of the cost should be paid.

4.3. A refund will only be issued if the you have paid in full and decide to cancel the commission prior to the approved sketch.

4.4. If you have paid in full and receive the sketch for approval, you may only receive a refund if you cancel prior to receiving the finalized piece. You will only receive a refund for half of the full commission.

Lazo's TOS says that a refund will only be issued if the comm was paid in full, which it was.

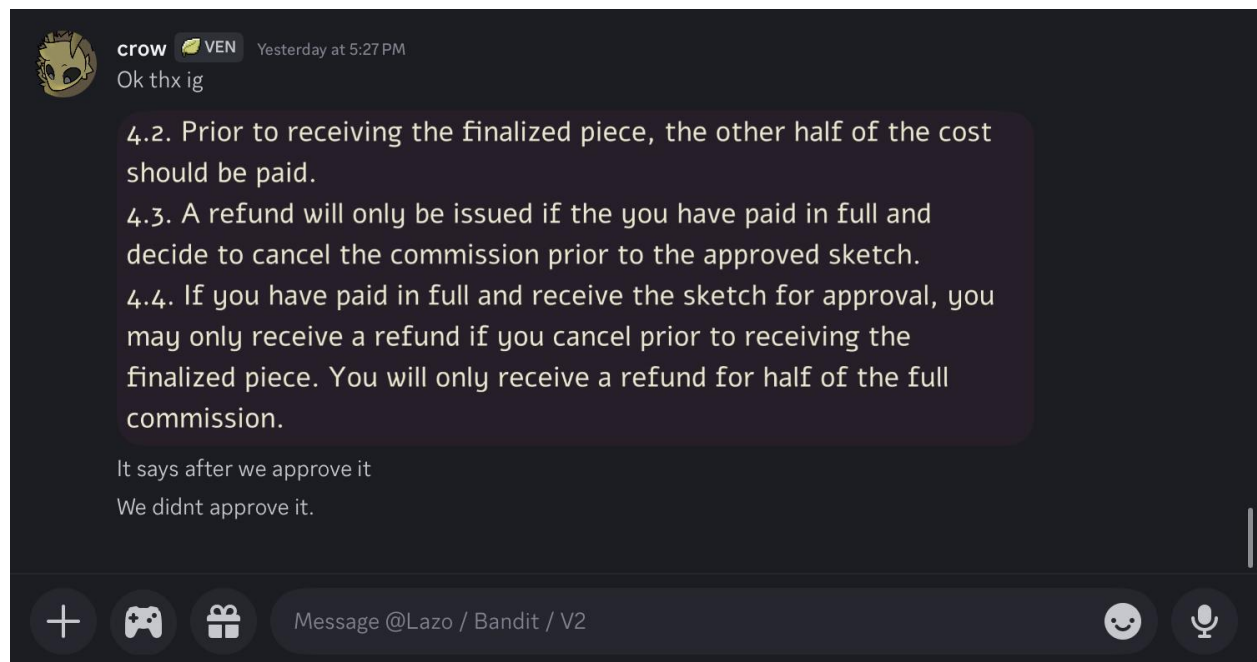
Here's where it gets tricky.

The TOS says that a refund will only be provided half if the sketch is approved. However, I never approved any of the sketches.

Lazo sent \$30. I would hope, like, he would keep at minimum \$5 for the pose revision, maybe \$15 kept at max. It's just sketches, and especially if I never approved them??



I DM'ed Lazo about his TOS, and no response so far.
