#### Discussion Items (2:35-4:30)

- 2:35-2:55 Legislative Update w/ Rachel Cohen
  - CSU Area F submission results should be know by the end of April
  - Stop gaps are in place to help students complete AD-T's for now, but conferring AD-T's will become more challenging without CSU Area F-approved courses.

- As reported and shared in her segment, Rachel produced a detailed spreadsheet of the CSU Area F
  approvals across the state. Currently, 45 community colleges have zero approved courses. On average,
  statewide, there are fewer than two approvals per college.
- A couple of approved outlines from another college were looked at, and CC members were somewhat shocked at how undeveloped the outlines were and that not much of CSU's criteria was met. Why, then, were CCSF's outlines rejected? CCSF outlines are very clearly rooted in the PCAH and have been praised by CCCCO for going above and beyond in order to be rich, useful documents.
- As mentioned numerous times over the past year, this whole issue, from the speedy legislation to the review process, needs a serious, organized inquiry by CCC leaders in contact with CSU leaders.
- 3-3:40 Approved ASEC <u>Resolution on DEA Development</u>
  - Katryn Wiese joined the meeting to discuss this recently passed resolution, and much discussion followed. The resolution calls for DEA to be developed by departments and not be a direct product of online teacher training. The resolution calls for a "discoupling" of a specific instructor with a DEA, as a department's DEA will already be in place. Instead, DEA will already be in place, but only trained teachers will be eligible to teach those courses online. Since the DEA Subcommittee reviews DEA, and DEA are part of CC agendas approved by the CC, it seemed like a relevant topic, one that would also give CC members more context on what they are approving.
  - Several concerns were expressed, including a greater potential for financial aid fraud (Title 4). Arguments
    were made about the logic of those claims since regular and effective contact is not being removed by
    this resolution, and untrained teachers will not be scheduled to teach online. Substantive contact is a
    departmental/evaluation issue. Internal auditing will be needed on a regular basis.
  - There was also discussion about how this resolution alters the current process, how that process came to be, and the pros and cons of change. Members praised the rigorous training but expressed the need to alter parts of the process in order to strengthen departmental planning and teaching capacity moving forward.

- 3:50-3:55 Members were reminded of the <u>Survey</u> on Common Course Numbering (<u>legislation</u>) and to comment
  on CC pilot membership <u>resolution</u> and Area H <u>resolution</u>. Squad time also had to be deferred due to the length
  of prior discussions.
- 3:50-4:30 Curriculum within the Context of Program Review
  - Pam Mery joined the CC to observe discussion of <u>Curriculum Currency reports and their relation to the curriculum process</u>. Members discussed departmental processes as far as curriculum discussions. A few departments—HLTH, ESL, ENGL— have their own curriculum committee. Some have subcommittees based on levels and subject, and discussions happen in department listservs. CTE departments' annual advisory meetings trigger curriculum conversations. Not all departments have large group discussions, and smaller departments try to engage with other small departments. Engagement can be challenging.
  - Several members said they had a hard time seeing the benefits of program review but have wanted to find ways to get more out of it. Aggregate reporting was credited with helping drive curriculum more than curriculum currency reporting. There was dialogue on what "currency" means: needs, updating teaching practices, outline content, outlines being up to date, avoiding expiration, meeting industry demands.
  - When comparing currency reports, members noted that some reports focus on meeting deadlines, others focus on changes they hope to make in courses and programs, and others seem more student-focused and list many things happening in the department. Formatting also varies greatly. The conversation then focused on providing more guidance in the report expectations and that relevancy should be seen as a very significant part of currency.
