4. Objective and topics addressed during the meeting

Analysis of 1st Year Review Report

Analysis of 1st year Review Report

Juanjo: we have to agree on a set of short-term goals to assign maximum priority to:

- Delivering of the software releases, guides and unit testing plans by THIS
 WEEK. If this means there are GEs that won't be delivered, that's fine. Cost
 reports control measurements will be put in place as agreed.
- Deployment of all released GEs by end of this week, maximum MID NEXT WEEK (week of August 6th):
 - We need to announce tomorrow to the UC projects (through the FI-PPP AB) what is the planning for the testbed
 - AP Juanjo and Stefano to meet tomorrow at 15:00 to agree on the message to be deliver. Stefano to prepare a draft before the meeting.
- Get the right information in the FI-WARE Catalogue describing how the GEs
 can start to be used by the UC project. We shouldn't consider that a GE can be
 published for use by the UC projects until all the required information is
 available on the FI-WARE Catalogue. Stefano as owner of the Testbed has the
 right to reject publishing of a GE on the Testbed because information about the
 GE is considered not complete. A GE will only be made available to the UC
 projects once the corresponding WPL, the Testbed WPL and the Tools WPL
 agree.
- A full FI-WARE Testbed already including Cloud Hosting capabilities should be ready by mid September (ideally, to be demo during the FI-PPP AB meeting in Israel, September 12-13) - this to be shared with the UC projects in the message to be shared with them tomorrow about availability of the Testbed.

- Resubmission of the FI-WARE Technical Roadmap should be accomplished also THIS WEEK. This will consist in incorporating references to the now revised Epics and Features in the Backlog. This would be a matter of adding some tables regarding major releases for each Chapter.
- We should define a plan to update the stakeholder field of all Epics/Features to the best of our knowledge (relying on input from Educational Weeks). Once we get the FI-WARE Technical Roadmap ready, we should share it with the UC projects and ask them to review it and add their support on whatever Epic/Feature they believe they will use. We can use the FI-PPP AB for that, but we also need the support of some partners leading some of the UC projects like ATOS, Thales or Orange to push this. THIS HAS TO BE COMPLETED BY END OF AUGUST.
- We should publish a spreadsheet, to be shared through Google docs with the UC projects, that will help us to get a clear picture of who is going to use what GEs. This to be ready by mid of August. This will require that Stefano publish a first version based on the information he already compiled, then share it with the FI-PPP ABs to complete setting a deadline by mid of August (to be reviewed in virtual FI-PPP AB meeting in August).
- The deliverable on "3rd Innovation Enablement in FI-WARE" should be finalized by August 10th at the very latest. Maybe it is not in the critical path, but will help us to gain credibility.
- We should organize a peer-review revision of FI-WARE GE Open Specifications to be carried out during August. This shouldn't be a hard task to do if we organize it properly. And it would put us in good shape to meet the re-submission of those specifications by month 18.
- We should organize a peer-review of the Architecture and Technical Roadmap deliverables during August.
- White paper on encompassing usage of GEs: I agree that the White Paper we promised is critical and therefore we have to make progress on it ... but it is also true that I have reached the limit of my throughput. I thought it was important to focus on delivering the software releases and reaching a certain level of quality regarding some of the material we are now going to deliver. I also felt that we needed WPLs and WPAs concentrated in delivering the GEs and the update of the backlog (crucial for resubmission of the Technical Roadmap) not adding too much distraction (just see how far we have got with the deliverable on 3rd innovation enablement to add one more). I hope that I will be able to launch development of this white paper before I leave on holidays (this Thursday) but this task will require that all WPLs assume part of their responsibility seriously. I will only be able to provide the ToC, include the figures I used in the review and provide some reference example for some chapter (I was thinking on the backend part of the IoT chapter). We committed to develop contents relying on a general example, maybe linked in aspects that are common to any SMART City application. There was an action point on UC projects identified during the Espoo meeting about them creating a paper explaining how they plan to use FI-WARE but this was an action point on them and we cannot count they will deliver. We should try to get the technical paper finished by end of this month.

- Review of Agile methods to simplify it a bit but start applying it rigorously starting in September.
- Make sure that we accompany UC projects during their first take trying to use the FI-WARE Testbed
- What can we do about exploitation? Wasn't there a WG formed after the meeting of Top Executives with the EC?

Other actions: Better Dissemination

Seville event. We need to bring commercial people there and show some genuine interest.

- Telefonica shall try to make it a larger event, with participation of Spanish associations and Celtic people.
- We need presence of commercial representatives of your companies

Barcelona Event (February)

- we need to present something working there

We need a better web page and more effective communication

- needs further analysis

Other Actions. towards H2020 but also sustaining PPP

There has been a discussion between G13 companies and three groups have been formed with ideas on

- a) improving dissemination
- b) improving PPP governance
