Welcome to **Oasis Soccer** (the "Game"), a free browser game provided by Oasis Security Ltd. ("us"). By playing the Game you agree to these Terms, whether or not you click 'I agree' or check any box (the "Terms"). If you do not agree, please do not play.

1. The Game

Oasis Soccer is a free, browser-based arcade soccer game offered for entertainment and promotional purposes in connection with oasis nhi worldcup 2026. We may change, suspend, or discontinue the Game (or any feature, including the leaderboard and any promotion) at any time without notice.

2. Eligibility

The Game is intended for a general audience. If you are under the age of 18, you may only play with the involvement of a parent or guardian who agrees to these Terms on your behalf.

3. Acceptable use

When using the Game, you agree not to:

- cheat, tamper with, reverse engineer, decompile, or modify the Game or its code;
- use bots, scripts, or automated means to play or to manipulate scores or the leaderboard;
- attempt to disrupt or gain unauthorized access to the Game or its hosting;
- enter offensive, unlawful, or infringing text (for example, as leaderboard initials); or
- use the Game in any way that violates applicable law or these Terms.

We may remove leaderboard entries or restrict access at our discretion, for any reason, including suspected cheating or inappropriate content.

4. Prizes and promotion

Any prizes offered in connection with the Game (for example, via the Competitive leaderboard) are part of a promotional activity run by Oasis.

Prizes, eligibility, how winners are determined, and how prizes are awarded are governed by separate Official Rules, which control in the event of any conflict with these Terms.

Where required, the promotion is void where prohibited, subject to verification of eligibility, and may exclude Oasis employees, contractors, and their immediate families. Prizes are non-transferable and may not be exchanged for cash except at our discretion. Winners are responsible for any applicable taxes. Oasis reserves the right to disqualify any entry it believes

was obtained through cheating or error or in violation of these Terms, and to substitute a prize of equal or greater value.

5. Data and privacy

Casual play does not require an account. If you join the Competitive leaderboard, we collect the name and email you submit, plus your match score and result, to display rankings and contact prize winners. That information is stored on our servers (via our database provider). Gameplay preferences such as daily streak and daily best score are stored only in your browser unless you clear site data. We use Vercel Analytics for aggregate site usage. Hosting providers may log technical data (IP, browser type). See our [Privacy Policy] for details.

6. Intellectual property

The Game, including its code, artwork, the Oasis name and logo, the "Ozzy" mascot, sounds, and original characters, is owned by Oasis and protected by intellectual-property laws. You may play the Game for personal, non-commercial enjoyment. You may not copy, distribute, sell, or create derivative works from the Game without our written permission.

All other names, marks, and trademarks referenced in the Game are the property of their respective owners. The Game is a work of parody and fan entertainment and is **not affiliated with, endorsed by, or sponsored by** any football player, club, league, or governing body, or any owner of the marks referenced.

7. No warranty

The Game is provided **"as is" and "as available," without warranties of any kind**, express or implied, including fitness for a particular purpose and non-infringement. We do not warrant that the Game will be uninterrupted, error-free, or free of harmful components.

8. Limitation of liability

To the fullest extent permitted by law, Oasis and its affiliates will not be liable for any indirect, incidental, special, consequential, or punitive damages, or any loss of data, arising out of or relating to your use of the Game. To the fullest extent permitted by law, our total liability relating to the Game will not exceed 0 USD.

9. Changes to these Terms

We may update these Terms from time to time. Changes take effect when we post the updated Terms with a new "Effective date." Your continued use of the Game after changes are posted means you accept them.

10. Governing law

These Terms are governed by the laws of Israel, without regard to conflict-of-laws rules. Any dispute will be subject to the exclusive jurisdiction of the courts located in Israel.
