# **Privacy Policy**

This privacy policy applies to the Crypto: Signal and Analysis app (hereby referred to as "Application") for mobile devices that was created by Roses Apps (hereby referred to as "Service Provider") as an Ad Supported service. This service is intended for use "AS IS".

#### Information Collection and Use

The Application collects information when you download and use it. This information may include information such as:

- Your device's Internet Protocol address (e.g. IP address)
- The pages of the Application that you visit, the time and date of your visit, the time spent on those pages
- The time spent on the Application
- The operating system you use on your mobile device

The Application does not gather precise information about the location of your mobile device.

The Service Provider may use the information you provided to contact you from time to time to provide you with important information, required notices and marketing promotions.

For a better experience, while using the Application, the Service Provider may require you to provide us with certain personally identifiable information, including but not limited to:

- Email address (for account functionality)
- Name (for personalized user experience)
- Terms & Conditions acceptance status (to track your consent)
- Timestamp of account creation and actions

The Application uses Firebase Authentication and Firebase Storage to manage user accounts and store user data. Only the minimal necessary information is collected to provide the Application's services. Your password is not stored by the Service Provider and is securely managed through Firebase Authentication.

The information that the Service Provider request will be retained by them and used as described in this privacy policy.

## **Data Storage and Protection**

All user data is stored securely in Firebase Storage and protected using industry standard methods. The Service Provider implements appropriate technical and organizational measures to protect your personal data against unauthorized or unlawful processing, accidental loss, destruction, or damage.

## **App Tracking Transparency**

In accordance with Apple's App Tracking Transparency framework, the Application will request your permission before tracking your activity across other companies' apps and websites. You can change your tracking preferences at any time in your device settings under Privacy > Tracking.

#### **User Account Deletion**

The Application provides users with the ability to delete their account and all associated data at any time. To delete your account:

- 1. Go to your profile in the Application
- 2. Select the "Delete Account" option
- 3. Confirm your decision

Upon account deletion, all personal data associated with your account will be permanently removed from our systems within 30 days. Some anonymized analytical data may be retained for improving the Application.

## **Third Party Access**

Only aggregated, anonymized data is periodically transmitted to external services to aid the Service Provider in improving the Application and their service. The Service Provider may share your information with third parties in the ways that are described in this privacy statement.

Please note that the Application utilizes third-party services that have their own Privacy Policy about handling data. Below are the links to the Privacy Policy of the third-party service providers used by the Application:

The Service Provider may disclose User Provided and Automatically Collected Information:

- as required by law, such as to comply with a subpoena, or similar legal process;
- when they believe in good faith that disclosure is necessary to protect their rights, protect your safety or the safety of others, investigate fraud, or respond to a government request;
- with their trusted services providers who work on their behalf, do not have an
  independent use of the information we disclose to them, and have agreed to adhere
  to the rules set forth in this privacy statement.

## **Opt-Out Rights**

You can stop all collection of information by the Application easily by uninstalling it. You may use the standard uninstall processes as may be available as part of your mobile device or via the mobile application marketplace or network.

## **Data Retention Policy**

The Service Provider will retain User Provided data for as long as you use the Application and for a reasonable time thereafter. If you'd like them to delete User Provided Data that you have provided via the Application, please contact them at rosesapps1@gmail.com or use the in-app account deletion feature, and they will respond in a reasonable time.

#### Children

The Service Provider does not use the Application to knowingly solicit data from or market to children under the age of 13.

The Application does not address anyone under the age of 13. The Service Provider does not knowingly collect personally identifiable information from children under 13 years of age. In the case the Service Provider discover that a child under 13 has provided personal information, the Service Provider will immediately delete this from their servers.
