-Terms of Service-

By commissioning me you automatically agree to the following Terms and Conditions:

1. Payments, Invoices, Refunds and Cancellations

1.1. Payments and Invoices

- a. Payments for any orders / commissions are made via paypal invoices
- b. Invoices may be edited after they have been sent out to correct any errors that may have occurred. The customer will be made aware of this via an email from paypal, notifying them of this change.

1.2. Refunds and Cancellations

- a. Refunds can only be requested if: your order hasn't already been processed / if I haven't started working on your commission / has taken longer than 3 months to complete.
- b. I reserve the right to cancel commissions whenever I deem it necessary. You're at a higher risk of having your commission / order canceled if you are rude, abusive or unresponsive for a week or more unless we discussed this prior.
- c. Only if I canceled your commission may you receive a full or partial refund, depending on whether or not I have started working on your commission yet.

2. Private, Anonymous and Surprise Commissions

2.1. Private Commissions

- a. I do not accept private commissions. Private commissions imply not posting my own artwork at all.
- b. By commissioning me you agree that you are aware of this and you can therefore not request a refund afterwards.

2.2. Anonymous Commissions

- a. If you would like me to post your commission but would rather I didn't mention your (user)name anywhere I can and will do so at no additional charge.
- b. Should someone be able to guess your identity then this is not my fault. You cannot ask for a refund.

2.3. Surprise Commissions

- a. Surprise commissions will not be posted until the date given to me by the customer.
- b. Surprise commissions do not cost extra.

3. Privacy and Confidentiality

- a. Never will I leak private information e.g your address or full name intentionally, the only way such information could be leaked is if someone was to hack my accounts.
- b. Should this occur then I'll try my best to gain back control over it all. I will try my best to take any posts down that show your private information.

4. What I Will and Won't Draw

4.1. What I will draw

- a. Pony, furry & human characters
- b. Feral, semi-anthro, anthro & chibi
- c. LGBTQ characters
- d. NSFW including BDSM
- e. Candy Gore & Soft Vore
- f. Extreme Gore

4.2. What I won't draw

- a. Rape or General Abuse
- b. Underage / loli / foalcon / cub porn & diaper fetishes
- c. Sexit, racist or anti LGBTQ themed artwork / characters
- d. Scat or vomit
- e. Mechs, Robots, Complicated Armor

5. Regarding NSFW Commissions

- a. To commission NSFW / 18+ artwork from me you must be 18 years of age or older.
- b. If I suspect that you are underage I will blacklist you. I won't be doing business with you ever again and I will make a public post about you (an "artists beware").

6. The Commission/Order Process

6.1. How to commission me

- a. Go to my website deerteeth.carrd.co
- b. Have a look at what I offer and my prices
- c. Fill out the appropriate commission form
- d. *Wait* for me to send you the invoice
- e. Your name will be put onto my trello soon afterwards, you'll be contacted with updates on your commission

6.2. How long it will take

- a. I work on commissions as fast as I can and usually have standard commissions done within 1 week.
- b. Complicated commissions (ref sheets, full scenes, paintings etc) will take longer
- c. I take the occasional day(s) off (this will be said in my trello)
- d. Surprise commissions will be completed before the date given to me by the customer.
- e. It is advised to only commission me if you are patient. I have done commissions for more than 3 years and always delivered but due to the amount of orders I receive it can take me awhile to get to your commission

7. Returns / Exchanges

Due to the kind of work I do I can not offer to return or exchange any of the items I sell as they are all custom made.

8. Edit Requests

When ordering, be as clear as you can and use refs whenever possible.

After I have provided a first sketch, please tell me what needs adding or changing, as major lineart alterations will not be made after completion.

Props cost extra and will not usually be added after the lineart has been finished.

9. Commercial Use, Creative Commons License, Modifications and Copyright

My artwork, commissioned or other, is licensed under a Creative Commons Attribution-NonCommercial-NoDerivatives 4.0 International License.

My work may never be used for Commercial purposes nor may it be modified in any way. You can not under any circumstances edit or copy my work without my express written permission. My artwork may only be shared if proper credit is given.

I will file a DMCA takedown if any of the above does not apply.
