- ✓ Camera To scan documents

You can **deny or revoke permissions** in your device settings, but this may affect certain features.

3. Subscription & Payment Handling

Subscription Payments:

- ✓ Our App offers subscription-based services via Google Play.
- ✓ No free trial is provided.
- ✓ Subscriptions automatically renew unless canceled at least 24 hours before the next billing cycle.
- ✓ You can manage or cancel your subscription in Google Play Subscriptions.

We do not process or store payment details—Google Play handles all transactions securely.

4. Rewarded Ads & Third-Party Services

- ✓ Ads are provided by third-party ad networks (e.g., Google AdMob).
- ✓ Ad providers may collect data (device ID, ad interactions) to personalize ads.

Analytics & Advertising Partners

We use **third-party services** to improve app functionality and monetization:

- ✓ Google AdMob For ad-based revenue
- ✓ Firebase Analytics To track app performance
- ✓ Crashlytics For app stability monitoring

These services may collect **non-personal device data** to optimize performance.
