



## Preamble:

When in the course of human events, war becomes inevitable for people to unite under national, religious, ethnic, color or otherwise tribal and to fight one another. With nuclear capabilities being present that has the potential to destroy the world, peace and a united humanity becomes the only feiable option for we the people.

## Amendments:

- 1) Everyone in the DRU shall have the right to follow any religion that they choose. The representatives and other government officials shall make no law prohibiting the free exercise of religion or the absence of religion provided that the religion is victimless.
- 2) Everyone in the DRU shall be allowed to hold and exercise their political and non political opinions however radical they are. Nobody may be fired or not hired for their race, color, religion, sex (including pregnancy, sexual orientation and gender identity), national origin, age (40 or older), disability, genetic information, or political affiliation or ideology however extreme it is.
- 3) Being necessary for the security of a free state, the right of the people to keep and bear arms shall not be infringed.
- 4) No Soldier shall, in time of peace be quartered in any house, without the consent of the Owner, nor in time of war, but in a manner to be prescribed by law.
- 5) The right of the people to be secure in their persons, houses, papers, and effects, against unreasonable searches and seizures, shall not be violated, and no Warrants shall issue, but upon probable cause, supported by Oath or affirmation, and particularly describing the place to be searched, and the persons or things to be seized.
- 6) In all criminal prosecutions, the accused shall enjoy the right to a speedy and public trial, by an impartial jury of the State and district wherein the crime shall have been committed, which district shall have been previously ascertained by law, and to be informed of the nature and cause of the accusation; to be confronted with the witnesses

- against him; to have compulsory process for obtaining witnesses in his favor, and to have the Assistance of Counsel for his defence.
- 7) No punishment shall be excessively cruel for crime and the death penalty for any crime except murder, rape, or kidnapping is unconstitutional. States are allowed to abolish the death penalty for murder, rape, or kidnapping if they choose. If death penalty is selected then death must be intended to be painless or painlittle.
- 8) Neither slavery nor involuntary servitude except as a punishment for a victim producing crime shall be permitted.
- 9) World map One world nation Google Sheets determines representation. This is not winner take all; if a presidential candidate wins 10% of the population of a state, they get 10% of that state's electoral votes. Whoever wins the most electoral votes is the president using the Alternative vote method. States aren't allowed to split up without approval from both chambers of the house of representatives. All districts for representatives must be based on state boundaries, parallels, meridians, or natural boundaries.
- 10) Being necessary to prevent abuse of power, no politician or judge may serve for more than 16 years total in any position.
- 11) In order for any law to be implemented, it must pass through  $\frac{2}{3}$  of the senate and  $\frac{2}{3}$  of congress, the president must sign off on it and the judicial branch must have majority support. Judges are elected for the position and each judge represents a district.
- 12) Being necessary to improve relations between states, absolute freedom of movement and free trade is implemented between states in the DRU.
- 13) States are prohibited from having a military and the military of the Liberty Union shall be the sole protector of the nation from enemies foreign or domestic. All assets owned by the militaries of the states are now owned by the military of the Liberty Union.
- 14) The capital of the Liberty Union is New York City, which is a federal district.
- 15) The powers not delegated to the Liberty Union by the Constitution, nor prohibited by it to the States, are reserved to the States respectively, or to the people.
- 16) The Liberty Union has no official language at the federal level, but politicians and soldiers will have to know English due to the inherent nationalization of their jobs. Students would be taught English in addition to their native language and be bilingually immersed in English and their native language. States don't need English as an official language, however all ballots will contain English and any additional language(s).
- 17) Taxing and spending policy is debated every year and all taxes must be approved by the senate, congress, and the executive branch. The judicial branch also has to approve the tax policy. Executive order can't be used for taxing and spending policy.
- 18) Politicians may not raise more than \$100 from any individual donor and may raise no money from corporations due to the need to eliminate corruption.
- 19) Anything not addressed in this constitution is left up to the states or to the people.
- 20) In order to amend this constitution, you need all of the following:

- a)  $\frac{3}{4}$  of the senate
- b) <sup>3</sup>/<sub>4</sub> of congress
- c) 90% of the popular vote in the DRU
