

By Law and overall commissioning me, you are automatically agreeing to the terms of service below.

Any statement can be bound to change over time or if discussed with me, the artist, prior to the commission. Please read thoroughly.

## **I. GENERAL TERMS.**

The prices listed are fixed and base prices. As the artist, they are bound to increase with complexity, keep this in mind if your character has more than 5 base colors and many details (horns, wings, accessories, etc.)

You *must* be 16+ to receive any digital Commission and/or physical Listing.

If there is a potential customer under the preferred age, they must have proof of guardian/parental approval.

Every customer must be willing to give the artist their email/online mailing address for receiving invoices and their final product/s.

If there is a physical Listing (badge, paws, etc), every customer must be willing to provide their address information during shipping.

Every 18+ customer requesting a NSFW Commission must be willing to give valid I.D of their birthday and show a piece of paper with their current username they are commissioning the artist with on it. I.D that is outdated or not renewed can't and will not be used for identification. Both pieces of media must be in the same image and sent to the artist to confirm age to continue Commission. A face photo of the customer is not mandatory.

I have the right to refuse your commission request/order with or without a given reason under any circumstances.

Please write in a clear and nice manner. Provide clear, neat references. AI images are not welcomed under any circumstances. I do not accept walls of text if you have no reference for your character.

Any rude, aggressive and ill behaviour will not be tolerated and your commission will be canceled if it occurs.

Follow the rules provided in the Commission journal, Kofi Listing, physical Listing, YCH or Adoptable.

If you fail to follow the rules provided I have the right to decline your commission.

If I find out a customer has not read my TOS, the Commission will not be accepted.

If you break my TOS, I retain the right to reclaim any design you have gotten from me if I see fit to do so since you broke the rules.

## II. PAYMENT

I, the artist, will be quoting your total amount based on the order request, base prices, complexity, characters, background inquirer and taxes. Together, they will give the customer their final price. If they accept, the final price will be personally split into three sections.

- All commissions must all be paid in 3 sections.
- Mandatory 25% upfront of base price, 25% after sketch approved, remaining 50% left of base price before completion.
- The first 25% is an upfront deposit payment and unless you pay it, the commission will not continue. Must be paid within 24 hours.

I do not accept bitcoin or any other digital currency, including art trades. Character trades are accepted.

The methods accepted are PayPal, Kofi, Amazon Gift Cards, Direct Deposit (Canadians only), Discord Nitro and Throne Gift List. The Gift Cards shall only be paid through the commission widget unless stated otherwise.

Adoptables are to be paid in full and within 24 hours.

Payment plans can be discussed prior to first section Invoice. I can not allow plans longer than 2 months.

You will receive an Invoice for every payment if you wish to pay with Paypal.

## III. PROCESS

The turnaround time (TAT) to complete your Commission may take up to *a day to 3 months* depending on many factors such as;

Order of Commissions, complexity, work, health or family issues.

If any of the things stated above occurs you will be notified asap.

Work In Progress (WIP) will always be given whether the customer may ask for it or not, for process and edits. WIPs might be given as well if I, the artist, wonder something about the Commission. The customer is allowed to point out mistakes during the sketching phase and may ask for more or less here.

## IV. CUSTOMER SATISFACTION

I will do everything I can to make my customers happy, that is my top priority.

However after a Commission is finished, only small changes are allowed to be made.

Such as small colouring/markings mistakes.

Any great changes will come with an extra charge, such as an outfit change, outfit addition or subtraction, background change or anything that makes me have to redraw it completely.

If your reference was unclear to start with, then you are not allowed to do minor changes without a fee.

Please make sure to be clear in your order for what you aim for.

## V. COPYRIGHT / USAGE POLICY

My work is *never* to be used or represented in anyway for:

- Pedophilic, zoophilic, and babyfur (ABDL) content

And is an instant blacklist and block for the user who will be publicly posted everywhere I want for others to watch out for.

I, the artist, hold every right to the produced drawing, not the commissioner.

Therefore I'm allowed to use the copyrighted artwork to;

- Promote myself in any place or site.
- To display it anywhere to my liking.
- Post it wherever I want.

The commissioner is allowed to;

- Use the copyrighted artwork for personal use only unless agreed otherwise.
- Print the art, and claim the right of their character(s) but not the drawing itself.
- Use the art to promote themselves with proper credit given to the artist.

If you break the copyright infringement in any way, every right you had to the drawing will be retracted. The following is considered Copyright infringement:

- Reproducing/using the copyrighted artwork commercially. (Meaning making money of it in any way)
- Taking credit for the creation of the artwork.
- Removing any watermarks/signatures.
- Altering the artwork without my, the artist's, consent.
- Using and putting the artwork into AI. Those found using AI to use or alter my work will be blacklisted, blocked and publicly posted everywhere I want for others to watch out for.

A Purchase of Commercial rights to the artwork will always be 50% of the final price.

With commercial rights you are allowed to make any sort of merchandise with the artwork.

Use it in books, covers, as props, change it to your liking and promote your own brand with.

Credit is still required for usage of the artwork, even if altered or edited.

Commercial rights for Adopts are always pre-included.

## **VI. CANCELING/REFUNDING POLICY**

I have all the right to the mandatory deposit money you have given me.

You have no right to demand a refund from me under any circumstances after the mandatory 25% is received.

I have the right to cancel and refund your Commission at any time with or without a given reason.

I have the right to cancel your Commission before the mandatory payment is given, at any time with or without reason under any circumstances.

Holds for any Adoptables, YCH and/or Commission Slot, or other Listings can be canceled at any given time with or without any given reason under any circumstance. If you are underway of receiving any Listing, you will receive what I have currently for you, unfinished or not.

You may cancel or refund your Commission under only these circumstances:

- Change in personal plans
- Unable to pay the given quote (final base price)
- Unable to pay the remaining 75%

Constant excuses and/or refusal to pay the base price with real money will be blocked and your name will be publicly posted everywhere I want for others to watch out for.

Customers who have paid the remaining 75% will receive 30% for their refund, 10% if they paid the sketch approval. A reminder for all customers is that you pay the artist's time so if you are upset about your refund and make a complaint under any circumstances I will refuse any commission from you in the future.

If money has not been sent within the given timeframe, I, the artist, have the right to cancel the Commission and give your Adoptable or Commission Slot to other buyers.

If you file a chargeback against me, your right to everything I have ever made for you will be retracted and I have the right to sell the copyrighted artwork to new buyers. You will be forbidden to ever commission us ever again and I have every right to file a complaint.

## **VII. ADOPTABLE DESIGN POLICY**

When you purchase an Adoptable, you are agreeing to my full Terms of Service.

Only serious buyers should comment on the design(s) in question. You have 24 hours to pay from the moment I accept your offer or the Auction timer ends, otherwise the Adoptable will go back up for sale.

I do not hold designs whatsoever, do not ask. Only close friends will I accept hold requests from.

All of my designs, whether a custom or pre-made Adoptable, are sold for personal use unless otherwise stated. My designs are to never be used in problematic instances. Commercial usage still qualifies for designs and can be discussed for more information. (50% of base price. See '*Copyright/Usage Policy*' for more information.)

Do not claim original art as your own. I hold the rights to the original piece of artwork, and I retain credit as the original designer of the character (even if you make minor changes, I still retain that credit as the original designer of the character).

However, you may post the original artwork where you see fit so long as you give the proper credit. Any artwork you create that is your own or your commission, meaning anything else that is not the original artwork, you still need to give credit for the design.

I will never "claim" an Adoptable back from you. Once you purchase the character, and payment has been received in full, the character is yours to enjoy! (Unless rules are broken.)

You may resell the design for the same amount you purchased it for or less. (If you sell for more and break this rule, you will be blacklisted.) You may freely trade or gift designs. If you have any commissioned artwork, meaning artwork of said character/design that you paid for, you may resell the design for the additional cost of the commissioned artwork. Gift artwork, artwork you got for free in any way, or artwork you yourself have created, does not count--commissioned/paid artwork only.

You are allowed to make minor changes to the design, such as changing hairstyle, clothing, or adding things such as tattoos or piercings, but you are NOT allowed to make massive changes to the design or color palette without first asking me. If you have any questions or concerns regarding this, please contact me. I am willing to make changes to the design at a cost. You are not allowed to have anyone else alter the design either.

Once payment has been received in full, I will send you an unwatermarked copy of the character's artwork and initiate a transfer on ToyHouse if you have an account on there. If you have a TH account and I transfer to you there, you will already have the unwatermarked artwork in their gallery.

All sales are final. No refunds whatsoever.

If you break any of the rules here, my Adoptable Design Policy, or under my TOS in general, you will be blacklisted.
