64. Chairman's Remarks

Cllr S Dring reported the resignation of Clerk Mrs L Barnes. Chair to write on behalf of the Council to send their thanks and very best wishes.

65. Reports from South Gloucestershire Councillors on matters relating to the parish CIIr S Hope reported:-

The Council has agreed to an increase of 3.99% to the Council Tax; this includes 2% to help cover the increasing pressure of social care costs. The Council also agreed to a £6 reduction in the Green Bin Tax; this against the background of reduced spending on Youth Services and the imminent closure of Libraries and the ceasing of the Mobile Library.

As part of the Council's Cost Cutting, the Conservative administration has also cut the Area Forums where local community grants were allocated. At the time of writing there is no local engagement and no plans for the continuation of community grants. In the past the area has benefitted from community grants and New Homes Bonus monies.

The number of committees has also been cut – Development Control Committees (Planning) and Licensing Committees will remain, as will the Health Scrutiny Committee; there will be an Environment & Community Committee and a Children, Adults & Health Committee as well as a Policy & Resources and Resources Committee. The Council has agreed to a Boundary Review Commission to review the number of councillors on South Gloucestershire Council. Currently there are 70 councillors representing the South Gloucestershire Area, this number is likely to be reduced.

In the recent budget there was an announcement that there would be greater devolution for the West of England with a metro mayor being elected. This will include greater government investment in the area for economic growth and more development. £30m has been promised over 30 years, this does however mean a lot of power will be devolved to the locally elected mayor

69. External Audit update

The Clerk gave the following update:-

External arrangements for 2015/16 (and 2016/17) are essentially the same as they were for 2014/15. The Council will have the same external auditor and the Annual Return is virtually the same. There are a few minor changes which are

- 1) The Annual Return must, as before, be approved at a Full Council meeting by 30th June, but the Annual Governance Statement must be approved before the Statement of Accounts is approved.
- 2) The unaudited Statement of Accounts and Annual Governance Statement must be posted on a freely accessible website along with a statement that the Annual Return as published may be subject to change.
- 3) Electors rights must also be advertised on a website. Councils subject to the Transparency Code for smaller authorities (where neither gross receipts or gross payments exceeds £25,000) must also publish the Statement of Variances and Bank Reconciliation that they send to their external auditors and also the internal auditors report in the Annual Return.
- 4) The period during which the electors may inspect accounting records is now set by the RFO, not the external auditors and must be for a period of 30 consecutive working days.
- 5) Electors objections to accounts must be made during the inspection period rather than after it.
- 6) As this Council is a Smaller Authority it incurs no external audit fee.

The Clerk is to attend an audit briefing by Grant Thornton on 15th April 2016.

For confirmation following last meeting ALCA advice is to do nothing and not to opt out of the new SAAA scheme.
