BACKGROUND

Technology is rapidly changing the world we live in. Health systems around the world are becoming increasingly digitalised. If done right, this creates a huge opportunity to strengthen the delivery, quality and equity of health services. With this has also come a vast increase in the amount of health data that is collected and used. This has sparked the need for stronger governance of that data to ensure it supports public good.

Despite the development of health data governance policies and legislation in several countries, there is currently no comprehensive, globally agreed principles, nor a global framework, to guide and inform countries developing their own health data governance legislation and regulation. Transform Health and partners have been working to help fill this gap by stewarding the development of equity and human rights-based Health Data Governance Principles, which are oriented towards supporting sustainable and resilient public health systems that can deliver Universal Health Coverage. They are a critical milestone towards the development of a global framework for health data governance to support the use of digital technologies and data for global public good.
