- Summer work parties? Blacktop painting/refresh
- Evening events with other families, in the school space.
- Put out more info about clubs, have an at-school club fair for the kids (several times?). Leadership middle schoolers or upper elementary leading affinity clubs (LGBTQIA, etc this has been seeded by counselor in the past).
- DEI book discussion, movie/book events (Hidden Figures example). Talking about community and the identity of community. Planning has to be careful not to assume that popcorn/pizza fundraiser or traveling to the west side is available to all families. Maybe the community isn't the building, but rather the people.
- Mechanisms for fostering micro-communities bus routes/neighborhoods will support engagement after school/evening via carpooling.
- Mentor families for new families host park meet-ups. Revive ACCESS Outschool - could be in person or virtual.
- <u>Emergency prep</u> might be a common denominator that would engage a bunch of families. Community Education for Access families regarding family preparedness and emergency response.
