## **Regulations for the Submission and Evaluation of Abstracts**

- 1. **Purpose:** The abstract should be a summary of the topic presented in the form of an "online poster." The topic should fall within one of the priority areas:
  - Health policy and social justice equality of access, financing, Health in All Policies, availability of health services, crisis situations, forecasting needs
  - Artificial intelligence in public health opportunities and risks for equity, ethical aspects and practical applications, data analytics
  - Public health potential within the system role of public health graduates, prevention and health promotion for all (school, workplace, campaigns), healthy ageing
  - Political and social transformations and health impact on health inequalities, diet, chronic diseases, inclusive system, counteracting health inequalities at every age and in every country, changes in the demographic pyramid—especially population ageing—new challenges for health and the economy
  - Public health in the face of 21st-century threats climate change, migration, infectious diseases, vaccination, international perspective such as the health system resilience index, regional experiences, transfer of good practices
  - Varia abstracts not fitting into the above topics but related to public health
- 2. Authors submit abstracts in English—only such abstracts will be published after acceptance by the Scientific Committee. The poster may be prepared in English or in Polish.
  - Selected abstracts will be published collectively in the journal *E-methodology* (https://journals.indexcopernicus.com/search/details?id=3894).
- 3. General Rules and Structure for an abstract in English
  - Introduction: Brief presentation of the topic and objective of the study (3–4 sentences).
  - Data and Methodology: Description of the research methods used (3–4 sentences).
  - **Results:** Summary of the most important findings (3–3 sentences).
  - Conclusions: Key conclusions or implications arising from the study (2–3 sentences).

- Maximum length: The abstract may not exceed 400 words.
- **Keywords:** Up to 5 keywords.
- Language: The abstract must be written in English.

## 4. Deadlines:

- o Abstract submission: By [5.11.2025].
- **Abstract evaluation:** Results of the evaluation will be announced by [13.11.2025].
- **Poster submission:** PDF or JPG/PNG files must be provided by [25.11.2025].
- **Conference:** The decision on inclusion of the English abstract in the *E-methodology* issue will be made at the conference.
- 5. **Evaluation Rules:** Abstracts will be assessed based on compliance with the guidelines, clarity of communication, originality, and substantive value.
- 6. **Disqualification:** Posters not compliant with accepted standards of scientific communication will not be published in the post-conference issue.
- 7. Poster Session: All accepted posters will be displayed online. The corresponding author is requested to respond by email to questions from Congress participants. Selected posters will be discussed at the conference if the participant is present on site.
- 8. **Copyright:** Submission of an abstract constitutes consent to its public release and possible editorial correction, as well as to posting the poster on the Internet. In the event of qualification for post-conference publication in *E-methodology*, the presenting author will be required to give email consent to publication.
- 9. **Final Provisions:** The organizers reserve the right to change the deadlines and the rules of the regulations; participants will be informed in advance.
