Approval of Minutes

September 2013 –Minutes approved as submitted.

Discussion:

- Rooming house inventory
 - Stephanie Crane contacted Andy Prickett, City of Oshkosh, and was able to get an updated list of rooming houses. She will forward the information to Brent to share with the group.
- Affordable Care Act
 - Brittany Teresinki, Outreach and Enrollment CAC, and Kathryn Baez, Americorps Volunteer WREN Coordinator, presented in representation for the Partnership Community Health Center about the Affordable Care Act (ACA).
 - The Youtoons Get Ready for OBAMACARE presented to explain the ACA in laymen terms.
 - Options of coverage: Employer, Government, Buy your own, No coverage
 - ACA effective 3/23/10
 - Dec 15: You need to be enrolled/ first payment made to have insurance
 Jan 1. (Exceptions: Life changing events)
 - Jan 1: Everyone must have insurance
 - Oct 1 Mar 31: Open Enrollment (Enrollment is not automatic).
 - Resources available. Email Brittany at brittany.teresinki@thedacare.org if you have questions.
 - Wisconsin chose not to expand Medicaid. Partnership aims to help people losing coverage to get information on how to get enrolled in Marketplace.
 Children will not lose Medicaid, but parents will lose Medicaid

- (Badgercare) if they have income above 100% of the FPL.
- Subsidies are sent directly to insurer.
- Tax credits available.
- Kaiser Family Foundation has a subsidy calculator available online.
- Be careful of scams enrollment cannot be completed over the phone.
 Senior Citizens are targets. Medicare is not part of ACA.
- Healthcare.gov place to enroll. You can print out paper applications from this website.
- Focus at Partnership: Connecting people to care. They currently have five "Certified Application Counselors" and are working on setting onsite enrollment sessions at numerous agencies, such as the library.
- What to bring to enrollment:
 - SSN
 - BD
 - Tax form, W2, or Wage Statement
 - Health Insurance Number (Plan number)
 - If you have an option to get insurance through your employer or parents, you would have to bring a statement showing these options.
- Partnership is providing slideshow to Housing Coalition members by email.

 - Last meeting in September, the group took at tour at Partnership Health Center.
 - Next meeting is October 9, 2013 at Salvation Army. Amy is working on having a guest speaker from Molina Health Care. Molina is a Qualified Health Provider (QHP) in our area.
- August shelter census- Brent Wojnowski, ADVOCAP (Taken last week of August)
 - Father Carr's
 - Bethlehem: 19 individuals
 - Holy Villa: 25 people in families; 16 individuals
 - Advocap
 - Rapid Rehousing: 7 individuals; 6 families (consisting of 20 people)
