The abstract in the English language should be written only in one paragraph, 8 point type, and Times New Roman font. The abstract contains a clear elaboration of research purpose, method, result, and conclusion. The number of words in the abstract is between 150 and 250 words. Reference should not be written in the abstract, but if it is indispensable, the authors' name and publication year should be cited. The nonstandard abbreviation should be avoided, but if it is essential, the full name should be specified in its initial mention.

## **INTRODUCTION**

The introduction contains the purpose of article/research that is formulated and presented by an adequate introduction and avoids detail references and research result presentations. The introduction should include background, research urgency and gap analysis with existing research to show the novelty. The purpose of the research should be clearly seen in the introduction. The introduction should be straightforward.

## **METHOD**

This section should describe in detail how the study was conducted. It includes information on the participants/population/sample, instruments, procedures, and data analysis. A complete description of the method used enables the reader to evaluate the appropriateness of the research methodology.

## **FINDINGS AND DISCUSSION**

The results and discussion are written in one unit; the author is not justified based on the results and prior discussion in the form of a new chapter. How to write in the results and discussion is done directly by reviewing directly one by one, the research results obtained

with relevant references and prioritizing from primary sources. The results of the study can be equipped with tables, pictures and graphics to clarify the presentation of the research results verbally.

The results and discussion should be presented in the same part, clearly and briefly. The discussion part should contain the benefit of the research result, not the repeat result part. The results and discussion part can be written in the same part to avoid the extensive quotation. Tables or graphs must present different results. The results of data analysis must be reliable in answering research problems. References to the discussion should not repeat the references in the introduction. Comparisons to the findings of previous studies must be included.

## **CONCLUSION**

This section contains research results, research findings in the form of answers to research questions or the state of digest results of the discussion. The conclusion of the research is presented briefly, narrative, and conceptual. The research impact must be stated. This section is presented in paragraph form, not numbering/listing. Just like the second part above, since the first paragraph, the first sentence is also written indented into one tab. Conclusions are presented in one paragraph.

5. If you are citing more than one references, put them in alphabetical order (Andrew, 2016; Bella, 2013).
6. For no author article, use title of article in quotation marks in place of author's last name ("The Implementation of Task Based Learning," 2015, p. 8).




Figure 1. Sample (Times New Roman, 10 pt, centered)
