Keywords: Three keywords separated by comma (,), it should not be variable, research location. It is better if core concept of research. Example: Mudharabah, Finance

INTRODUCTION

The introduction section basically contains the background, the problem studied, and the purpose of the research. Questions such as the purpose of the research, why the topic is being researched, should be addressed in the introduction. So that the readers of the article can understand the flow of thought of the researcher / article writer well and clearly. However, all these sections are not made in the form of bullets and numbering format. But described in the form of sentences in paragraphs.

LITERATURE REVIEW

This section generally contains theoretical discussions related to the topics raised in the research. It is better to avoid writing definitions and definitions. Because in this theoretical review the priority is the theoretical basis used by the author/researcher as the basis for forming the body of research analysis..

METHODS

The research methods section does not have to explain all the steps or stages carried out in the implementation of the research. This section must be made in detail and clearly in order to facilitate the reader in evaluating the suitability of the



method, reliability, and up-to-date of the analytical tool with the objectives and problems discussed by the researcher.

Writing equations is written using the equation editor provided in MS Word. Equations are numbered if they are to be used again as a reference. If not, however, the equation does not need to be numbered.

The conclusion section must clearly state the results obtained. This section should answer the research question and summarize the research objectives. Conclusion writing is made in the form of paragraphs, without using bullets and numbering points.
