School Spotlight

Everett Principal Renee Fitzsimmons introduced Everett Parents, Shelly Marks and Katherine Hensley discussed the creation of the Everett Garden Club that was established this year. It now has 40 members, the focus is on nutrition, harvest management, curriculum, social and emotional learning. Suzanne Thomas, 3rd Grade Teacher along with some of her students spoke on the learning opportunities of the Garden Club.

President's Report

President Helms reported on the strategy session held earlier with District 115 to determine how the Board can be more focused on student learning. She expressed gratitude for all educators that have been working non-stop since the beginning of the school year. The Board is making more effort to be present in the

schools and community; thanks to Melissa Oakley for putting these events together. She discussed the new reading curriculum and rise in rest scores.

Superintendent's Report

Dr. Montgomery's report consisted of the following topics: 2023 Illinois State Report Card, Strategic Plan Metrics, Classroom Snack List, D115 Referendum Bond Sale, and Illinois School Board Members Day.

Three schools, Cherokee, Sheridan, and Deer Path East have advanced from the "commendable" to the "exemplary" designation. Everett and Deer Path West have received commendable designations. Overall the District's data has improved, Dr. Shinn will provide more detail during her report.

Dr. Montgomery turned it over to Dr. McHugh to present on the Strategic Plan Metrics. The metrics that will align to the goals of the Strategic Plan will be State Assessment Metrics, Student Portfolio Metrics, School Climate Metrics, Staff Climate Metrics, and Community Metrics.

The Pre K-4 Classroom Snack List Pilot ended on October 6, followed by a survey for families and staff. Based on the results effective January 16, 2024, classroom snacks must be peanut-free and tree-nut-free. Classroom parties will no longer include food.

On October 11, District 115 completed the successful sale of its AAA-rated General Obligation School Bonds, Series 2023. The tax impact on a home with a fair market value of \$1,000,000 will now be \$870 per year, \$104 less than the \$974 originally estimated.

Dr. Montgomery thanked the members of the Board for Illinois School Board Member's Day which is November 15, 2023.
