The quarterly meeting of the NRRWMC was called to order at 10:06 am by chair Keri Navratil, city of Storm Lake. Roll call was completed with 18 members present via teleconference and proxy votes which does not represent a quorum (21 members needed for quorum). The acronym NRR in these minutes stands for the North Raccoon River watershed.

- Q1 2021 = \$43,837 spent, running total \$1,238,475 which is over 50%, which means we will be taking part in a public hearing
 KEVIN & TYLER, EOR:
- Design is complete, environmental and floodplain reviews done on 4 projects
- Bid package is ready with one hold up due to an easement issue with a family trust
- 4 projects will be offered on one contract
- Lack of a watershed coordinator has meant little landowner outreach in the last few months
- Aiming for projects to be done between August 1 and September 1
