- Try to center optimism
- [Northern Appalachian Folk Festival](#)
- People, Places and Projects: Reimagining Your Community with New Federal Funding (Indiana County)
 - Always comes back to people and places
 - Community revitalization (very intersectional)
 - Having a County Government as a partner is a huge asset, especially with workforce development and community revitalization
 - Community Conditions: coal closures, poverty
 - Created a task force to address shuttered coal plant job loss
 - Bottom up approach to answer questions and come up with solutions
 - Brought together a diverse group for facilitated discussion (facilitation is key)
 - Environmental groups
 - Educational groups
 - Building and construction
 - Economic development
 - Collaboration → talking and listening
 - Federal Funding:

- Look and see if there are any organizations offering collaborative funding cohorts etc.
- Mix of soft and hard power

Question 1) What have you find helpful when it comes to communities helping each other? What kind of existing networks can communities plug into? What new connections need to grow?

- Climate Action Board
 - Found out that community wanted to do all sorts of things
 - Survey
- Municipal Leaders
 - Excited for what's coming up next and the opportunity to access federal funding
 - Community Change Grants are good to go for, longer time to apply
 - Talk Tuesday about coming back from trauma, substance abuse, and/or returning citizen = inspiring and the way to go
 - Focus on renewable energy, housing crisis, transportation
 - Everyone wants to be greener! It's NOW or never for our planet
 - Council of Governments (COG) → can be municipalities or county wide
 - Can apply for funds from EPA, but worry about how "sexy" it will look to EPA
- Cooperative Development
 - Provide technical assistance, business plan development, help folks interested in cooperatives (access significant capital)
 - Issue is the local support for the projects
 - How to convince people to support/how do we get some of this federal money to focus on this cooperative development work
 - A lot of pre-work training/educating people in a lot of different ways
 - A lot of them probably can start their construction/manufacturing businesses, but need time to find teams and create cooperative, then receive funding to start cooperative

- Looking for a way to develop local capacity to pull down federal money
- Having enough capacity is a big barrier
 - Need to understand how nonprofits work
 - Financial documents
 - What is the role of the Board of Directors? What is not their role?
 - How to run a nonprofit?
- CDFIs
 - There are mechanisms out there
- Housing ExPo
 - Bring together different community members that deal with housing issues
 - Do not have experience with city planner
 - City not really taking an active/proactive role in this
 - People want to work together but missing the driver (someone who can put the overarching vision together and facilitate/organize people)

Question 2) Have there been any resources that have been helpful for meeting project goals?

- Cohort with ARC - OVRDC
 - Led to the [Inspire grant](#)
 - ARC is led by a Commission composed of the Governors from each of the Region's 13 states, and a Federal Co-Chair who is appointed by the President and confirmed by the Senate. Each year, the governors select a States' Co-Chair to lead the Commission in partnership with the Federal Co-Chair.
 - Each Appalachian Governor selects an appointee to represent their states' interests and priorities to the Commission. These representatives, referred to as State Alternates, are liaisons between the Governors and ARC Leadership. Every state also has a State Program Manager who is the state-level contact for ARC and facilitates ARC investments with ARC staff. Alternates and State Program Managers work closely with local organizations, including Local Development Districts, to guide ARC investment decisions and policy decisions. ARC staff review proposals, manage investments, and conduct research in cooperation with the states.
 - Addition is an issue in the region >> Inspire Grant is reopening
 - Collaboration between business and community action
 - Broadly: public private partnership
 - Success coach who acts as a caseworker → someone who works at the organization/business who is here to help employees with issues
 - Childcare
 - Housing
 - Transportation
 - What is a Local Development District?

- Every region has its own LDD
- Get funding through the state but linked to ARC funding
- Boots on the ground middleman
- Try to facilitate federal and state dollars and local stakeholders
- Meetings with representatives from local counties
- Revolving loan fund

 - Can reach out to LDD (could be called rural development district) to see what middle person can provide in terms of assistance

- Suite of Social Services set up next to the local prison
 - WORC
 - Substance abuse place
 - Wrap around services
 - When applying to grants, it helps to explain the big picture and specify how much you need this year
- Has anyone seen good examples showing how ARPA and other federal stimulus funding received by local governments has been appropriated/used?
 - Circle
 - Work with communities to focus on these issues that we have discussed over a three year period
 - Have community support and federal funding
- Community Census
 - Communities tell us what data they would like to have collected
 - Hire people in the community, train and equip them to go out and talk to their neighbors
 - Gather information and use data to connect people with resource they said they needed
 - When doing a survey, ask people to volunteer and to connect with resources
 - Able to use tax credit funding
 - Now that they have data, what is the community going to do with the data and get funding
 - Community can own this data
