#### What I Will Draw:

- ★ Anthros (planti and digi legs)
- ★ Most kinks (as long as they are legal and moral, feel free to ask me about a kink you have in mind before commissioning, to be sure whether I will do it or not)!
- ★ Mecha like protogens and synths (note that they WILL be simplified to fit my style!)
- ★ Any species (but canines are my specialty) and gender
- ★ Interesting fetishes and kinks!
- ★ Most drug use (e.g. pills, cocaine, weed) anything that you can smoke or snort

### **What I MAY Draw:**

A list of things that I may draw upon request, but have either never done before, or would need more information about the commission before making an informed decision. Please contact me first!

- ★ Vore (ONLY micro x macro vore though, and with characters sitting in the maws. I will not draw full size characters being eaten or the inside of somebody's stomach)
- ★ NSFW gore (contact me first and we can discuss it)
- ★ SFW art (I simply do not enjoy this as much, but depending on the idea I may be willing to draw it!)

# **What I Will NOT Draw:**

- ★ Any age related kinks (such as, but is not limited to: DDLG, ageplay, ABDL, etc.)
- ★ Feral NSFW
- ★ Animal genitalia (e.g. knots, horse dicks, etc.)
- ★ Any artwork that can be perceived as hateful, homophobic/racist, etc.
- ★ Cub porn, or any type of character that appears to be under the age of 18
- ★ Diapers (dirty OR clean)
- ★ Extremely giant and unrealistic plus size body proportions (normal plus size bodies is A-okay tho! But I will not partake in the giant inflation kinks)
- ★ NSFW fanart of characters in media that do not belong to you (e.g. FNAF characters, MLP characters, etc.)
- ★ Heavy drugs (e.g. heroine) anything that you have to inject
- ★ Other people's styles
- ★ Humans
- ★ Wings of ANY kind, or gradient/unclear designs (feel free to ask me first)

# **Terms of Service**

It is strongly advised that you read <u>all</u> the terms below before commissioning. They are legally binding and, should you choose to commission me, will be set in stone regardless of whether you read them or not.

#### **General Terms**

- I require a clear digital character reference before starting (I will not make art based on a description or multiple artworks that do not fit with each other). If you are ordering a ref sheet, please discuss this with me prior
- Regular commissions will not have due dates, but you may discuss one with me beforehand and we will work something out if that's what you need
- Your invoice must be paid within 48 hours (unless discussed prior), or your slot will be cancelled and given to somebody else
- I take all payments through PayPal invoice system and in GBP (£) only this is non-negotiable
- Unless specified by the client, you will receive one (1) WIP after the sketch is completed from then on I will complete the rest of the piece and the next art you receive will be the final
  product
- After the sketch is complete, you have the opportunity to ask for changes needed, and also
  ask questions to clarify. After the artwork is fully finished, I can only make minor changes that
  are the fault of my own any large changes or changes that were not given to me by you
  prior, may subject in an extra fee

If your commission is specific, please give me as much possible detail as you can upon requesting it. Be ready with correct and up-to-date reference sheets, specific ideas and images, etc., or let me know if you want to give me artistic liberty (if you choose this option, it is also a good idea for you to tell me your limitations and boundaries of what *not* to draw, just in case). If your ref sheet is for some reason incorrect, it is up to you as the client to tell me that before any work has been started - I can only draw what I am told and it is not my responsibility to chase you up to make sure the reference you provided is 100% correct.

Digital reference sheets are required so that I may colour pick correctly - if you insist on using a traditional ref sheet, you must provide hex codes to each colour, or an understanding that the character may not look exactly as you thought it would. Reference sheets must also be unshaded and clear to see/understand. If you provide me with a shaded ref sheet and the colour I picked was wrong, it is not my responsibility.

Following on, if your final piece is incorrect (and it was not my fault), you are *not permitted* to edit the artwork in any way, or hire another artist to edit it for you.

Please note that all the prices listed are *base prices*, this means that if your request or your character is extremely complex and will take me longer than normal to complete, additional fees will be added, but will definitely be discussed before any payment is made, to ensure you are okay with it.

If we have discussed a deadline, please ensure that you order at least 30 days prior to the due date, otherwise I may not accept your commission. I am unwilling to work with extremely short deadlines, however, if discussed prior, I may be able to work to a short deadline for additional payment.

#### Payments & Refunds

For my own protection, I require that all payments should be made upfront in full before any artwork is started. If we have discussed split payments prior, that is fine, but I will still not start on any actual work until I receive the full amount. Payment is accepted through PayPal only for now (but Kofi can be made available for clients if we have talked about it first). If you automatically assume and use Kofi without discussion, I will refund you and cancel the commission). If you wish to send a tip (completely optional and not required), let me know and I will give you my Kofi link.

I reserve the right to cancel or refuse commissions for any reason. If I cancel, you will likely be given a full refund (unless the artwork is more than 50% complete, then a partial refund will be given based on that).

If you want to cancel your commission, I can offer a full refund if the artwork has not been started yet. If your art is in the sketching stage, I can offer a partial refund. If the artwork is past the sketching stage and is starting to be refined, I unfortunately cannot offer a refund as I have already put a substantial amount of work into it. Fully completed artworks will also not receive a refund of any kind. Doing this will also revoke your right to the sketch, giving me the right to reuse it if I wish (e.g. another artwork, as a ych, etc.)

I will not 'hold' commission slots. If you are looking for a commission from me but cannot afford it at the moment, please withhold from asking and come back at a later date when you can guarantee to pay in full.

All payment is sent through PayPal invoice system, this is to avoid people trying to pay me with the wrong currencies. Please note that the currency I use, GBP  $(\mathfrak{E})$ , is the one from my country and I will not accept any other. It is not my responsibility to tell you how much your commission would cost in your own currency - you can find that information yourself by googling it. I will not change my prices if the commission is 'too expensive' when converted to your currency - my pricing is non-negotiable always.

# **Unauthorised Chargebacks**

Should you file a chargeback on a commission without asking me for permission first, I will immediately contact you to resolve the issue - whether your artwork is complete or not. If you do not reply or have blocked contact with me, you will either: lose your slot (if I haven't started any work yet), or lose the rights to the artwork you have received from me (even if it's only a WIP). This means that I have the right to edit your commission however I would like to, and re-sell the rights to somebody else (e.g. in a YCH, etc.). You will also be permanently and publicly blacklisted from commissioning me or owning any of my designs in the future, and I may warn other artists to be wary of you.

If you need a refund for an uncompleted commission/commission that has not yet been started, please sort it out with me and I will issue an authorised refund. Life can get in the way sometimes, I understand that, but I recommend commissioning me when you are guaranteed to have expendable funds.

#### **Rights & Permissions**

As an artist running a business it is important for me to advertise - so your commission will most likely be posted to my social media platforms upon completion. If for some reason you do not want this, or would like me to postpone posting (e.g. it's a birthday or anniversary gift), you must let me know when ordering, I will not remove art that has already been posted if we hadn't discussed the privacy of it beforehand. If you would like to remain anonymous, commissioned artwork can be posted with the clients' identity hidden. If you require that the final artwork cannot be posted, even under a hidden, anonymous identity, you must pay an additional Privacy Fee of 50% of the final commissioned price.

Unless discussed with me prior, all artwork you receive is <u>personal use only</u>. This means that you can use the art for things like: profile pictures, wallpapers, printed and hung on your wall/used as con badges, etc. You can also post your commissions to your own social media, providing you use proper credit to me!

Artwork meant for personal use cannot be used for profit, this includes but is not limited to: selling stickers, badges, clothing, products, etc.

You cannot, under any circumstances, claim to have made the artwork yourself, or try to give the credit to anyone other than me.

Once a final art piece has been presented to you and is confirmed/accepted, I can no longer make changes after the fact. It is your responsibility to make sure the final piece is up to your standards and that everything is correct. I cannot make changes after confirmation if you decided to look at the drawing after and realise something isn't right. All final changes will be made before the end confirmation.

#### **NFTs**

My art cannot be used for NFTs in any way, whether it's been commissioned or not. This includes but isn't limited to adopt designs. If you use any of my work for NFTs, you are directly breaking my T.o.S and automatically revoke all rights to your artwork, which gives me the right to re-sell it, if applicable.
