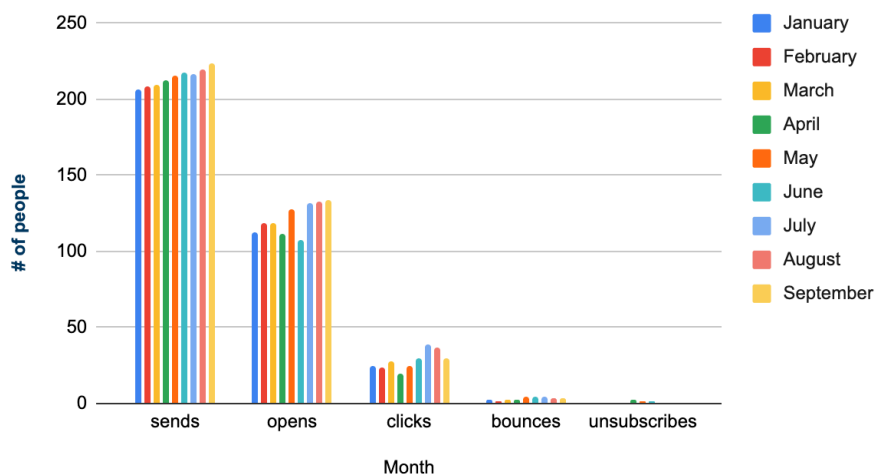

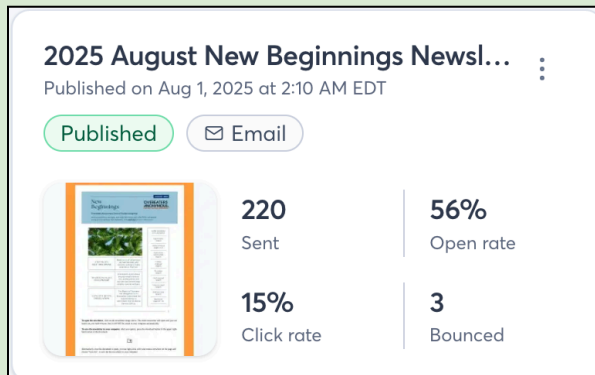
Newsletter Statistics 3rd Quarter of 2025

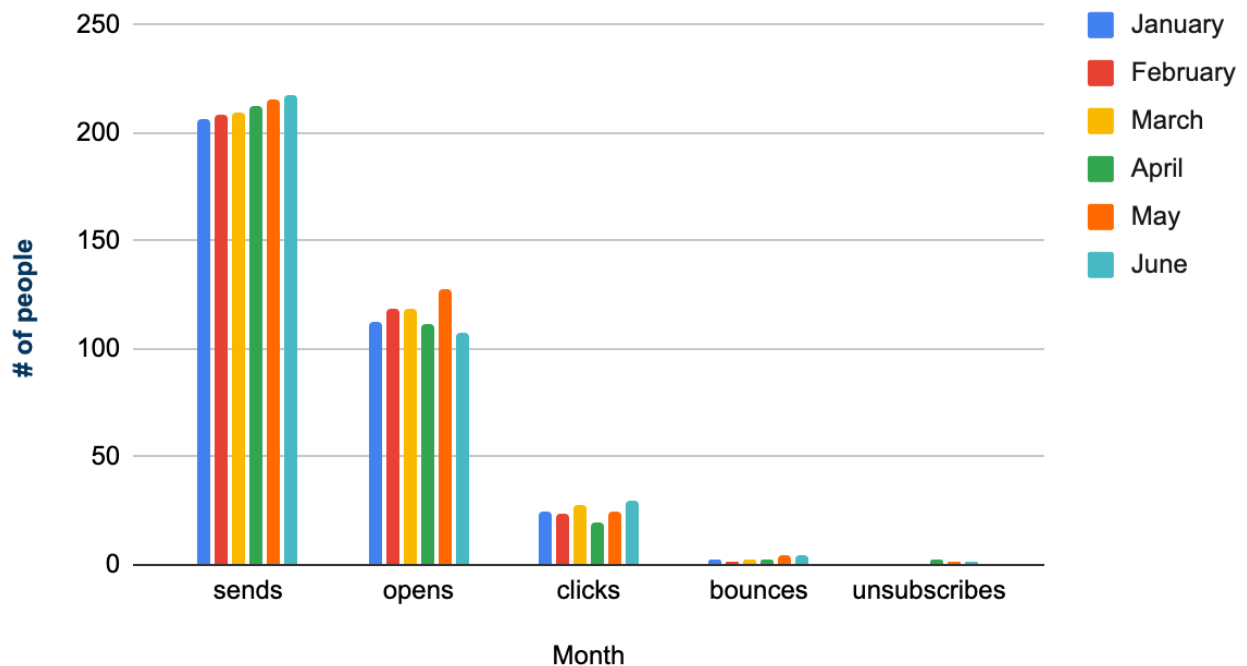
