

## ROBOROCK SOCIAL MEDIA "Christmas in July Giveaway" SOCIAL MEDIA GIVEAWAY – TERMS AND CONDITIONS

1. Instructions on how to enter this giveaway form part of the conditions of entry. By participating, entrants agree to be bound by these conditions.
2. Entry is open to residents of Australia and New Zealand who have an account on Instagram, enabling them to submit an entry in accordance with details below. Employees and their immediate families of the Promoter, its agencies and venues/outlets associated with this giveaway are ineligible to enter.
3. The giveaway commences on July 25th, 2025, and closes at 11:59PM AEST on July 31st, 2025 ("Promotional Period").

### How to Enter

4. To enter, entrants must, during the Promotional Period:
  - a. log into their Facebook account;
  - b. Follow @RoborockAU on Facebook
  - c. Like our "Christmas in July Giveaway" posts
  - d. Comment - each comment is an extra entry!
  - e. Bonus entry: Share this to your stories and tag us or mention a friend in the comments. Each Story and comment is an extra entry!
5. By submitting an entry, entrants warrant to the Promoter that:
  - a. their entry complies with the Submission Criteria;
  - b. they own all of the rights to the entry;
  - c. They are at least the age of an adult in their jurisdiction (and at least 18) to participate in the giveaway.
