Bid Opening will be on **Tuesday, April 19, 2022 at 10:00 am.** prevailing time at the Superintendent's office; 801 W. Main St., Teutopolis, IL 62467. Bids will be publicly opened and read immediately after specified closing time.

The scope of work consists of removal of existing windows, infilling of window openings with concrete masonry units, and masonry restoration. This includes brick replacement, tuck-pointing, replacement of control joints, and masonry cleaning.

Prevailing wages in accordance with Effingham County is required.

Bid security is required, in the form of a bid bond or certified check in an amount equal to ten percent (10%) of the base bid as guarantee that the bid will not be withdrawn within 30 days after the date of opening of bids, and that the successful bidder will enter into a Contract for the work awarded them. Bid security shall be made payable to Teutopolis Community Unit School District #50.

Bonds are required: Both a Performance Bond or a Labor & Material Payment Bond is required for this project, each in an amount equal to 100% of the contract price.

Your Bid will be required to be submitted under a condition of irrevocability for a period of 30 days after submission.

The Owner reserves the right to accept or reject any or all Bids or any part thereof, to waive any informality in bidding, and to accept bids deemed most favorable to the Owner.

Award of a contract is anticipated to occur at the **April, 2022** meeting of the Board of Education. Begin construction on **May 31, 2022**. The Work shall be Substantially Complete on or before **July 29, 2022**.
