

TEMPLATE of letter to Councillors – You may wish to use the following template as a guide to preparing your own personalised letter or email to your local Councillor.

Dear Councillor.....

Urgent Medical Crisis That All Councils Must Consider

My name is.....

I am writing to inform you that information and evidence of possible crimes has been collated in respect of deaths and injuries that appear to have been caused by the Covid-19 vaccines.

I am reaching out to you because you are a leader in our community, serving in the government body closest to the people. Our Ambulance services and hospitals are in crisis dealing with unprecedented demand. People are sick and often repeatedly. You are out in the community with the people every day. You see what is going on, you must surely know people who are constantly sick, severely injured or who have died suddenly and unexpectedly, including your staff working within your Council.

Please read on. It would be easy to dismiss this email because you believe this is not in the remit of your role. But this is not a question of whose job this is, or which level of government is responsible. This is an issue impacting all Australians, so please uphold your duty of care for the health and safety of your constituents. Let's work together to bring these issues to light. If the issues with the vaccines are as devastating as the evidence appears to suggest, let's be honest with the people and address it. If we don't all stand up together to inform and protect each other, we don't have a civil society.

I am aware an email was sent to you on the 3rd of February 2025 advising you of this information, which included a link to a video titled 'Witness Statement 1 January 2025'.

If you have already watched the film, I wish to thank you, as this matter is of the utmost importance to me, and I look forward to receiving a response from you expressing your view on this issue.

If you haven't made the time, as my elected representative, to watch the film, I request that you do watch it as a matter of urgency. The film includes evidence and testimony from Australian and international medical, scientific, data and legal experts, as well as politicians, showing that the vaccination rollout had a devastating

impact on thousands of Australians and their families, all of whom have been left to pick up the pieces.

The film includes numerous facts supported by predominantly Australian-sourced data and evidence, but also includes information presented by global experts.

Watching the video will help you gain an understanding of the alleged crimes and the significant impacts on your constituents who elected you to represent them. The video is presented in 9 parts so that you can pause after, or during, each section to reflect and consider the information carefully. **Please watch all 9 parts.** I believe these to be the most serious crimes ever committed in this country.

We must all stand together now to solve this problem. Otherwise, we will likely see a lot more illness and disease, health problems and unexplained sudden deaths in the future.

The people need leaders who will **not** stay silent when they see people in their communities being injured and killed. I sincerely hope that you are one such leader.

Until now, you may have been unaware of events and actions that have caused so much death and injury in our country. But please inform yourself by watching the film. After doing so, I need you to fulfil your duty to protect the health and safety of your constituents, by taking steps to support the calls to the Australian police to investigate and prosecute the alleged crimes.
