 - i. Westwood Community School Foundation Account
 - 1. Total Balance: \$49,665.32
 - 2. Spendable Balance: \$22,517.21

 - 1. Total Balance: \$9,791.21

 - Follow up regarding account purposes
 - i. Westwood Community School Foundation Account
 - 1. This is what the Siouxland Foundation considers the endowment fund, and it is permanently restricted.
 - 2. The intent/investment objective of this account is long-term sustainability and funds are invested into the market.
 - 3. Fee for this account is 1.25% annually or 0.3125% quarterly based on balance.
 - 4. All donations that are received and are not specifically instructed to go to the special purpose fund will be deposited into this account to allow the donor to qualify for the Endow Iowa tax credit.
 - 5. Annually, 5% of the balance in this account will be transferred from fund income and become available for spending.
