- A Legislative Report was shared and AB 245, new additions to the Emergency Action Plan, was passed.
- Each team must practice the Emergency Action Plan starting July 1, 2024 and informed to be sure that coaches are aware.

- School sites must test every day for heat.
- A training or in service may come out by CIF.

- If the JV coach gets a red card, the JV coach gets a two game suspension.

- a. Winter Deadlines to Enter Schedules and Scores ([click here](#))
- Shared that last Wednesday was the deadline for all sports that use MaxPreps and asked to make sure for coaches to review the scores to ensure the accuracy.

- Information was shared that there is a tracker doing in-season rankings for all the wrestlers and the advisor representatives will meet using the data and create divisional championships.
 - Shared that seeding dates will be sent.
 - b. Status Update on North County LAX Open Division Proposal ([click here](#))
 - Shared that the lacrosse Open Division will be six teams in the playoffs instead of eight teams.
 - c. Status Updates on Revision of CIF Bylaws 600.1, 600.2, 510.1 ([click here](#))
 - Shared that the item is up for approval at the Board of Managers meeting tomorrow.
 - S. Giusti shared that SDCC is planning to vote for approval for Bylaw 600.1.
 - This approval will open up more flexibility for student athletes to get a lesson/training during the season.
 - Information was shared about Bylaw 600.2 and 510.1 that are clarifying language of what is permissible with students who do not attend the school, or whether it is incoming eighth grade students or ninth grade students who attend other schools to participate in camps, clinics, youth football and social media at schools.
 - d. Status Update on Metro Conference 70/30 Power Ranking Proposal for all sports using Power Rankings ([click here](#))
 - 70/30 graph and 50/30/20 graph comparison was shared to show how fall divisional placement will look like.
 - Based on data from the past five years, divisional placement will be 70/30 for 2024.
 - e. Status Update on the North County Post Season Divisional Placement- Football Playoffs Proposal ([click here](#))
 - All teams will be operating not placing a division, playoffs will be using Power Rankings.
 - All sports will be going to the end of the season seeding system.
 - CIF will meet with the Football Advisory Committee.
 - If it passes, it will impact 2024 football seeding procedure.
 - J. Briggs asked about automatic qualifiers, if this is going to eliminate small schools. The answer is that it does not look like this impacts small schools negatively.
 - R. Lardizabal asked if this is only for football in 2024. The answer is yes.
 - f. Officials Fees Increases Update
 - MOU signed with most of the officials associations for a two year cycle.
 - Flag football has another meeting.
 - R. Lardizabal asked if the allotted officials fee will go up. Answer is that SDCC will discuss it when SDCC updates the Blue Book.
 - g. Additional CIF Items
 - Shared that CIF is looking for increase of participation in Battle of the Fans 2023-24.
 - Ejections are down overall, but not in soccer.
 - Shared that soccer ejections are not only SDCC issues. Coaches/spectators are getting ejections due to not having supervision, and some sections do not require supervision.
 - New legislation says AEDs must be located less than a three minute walk from any athletic facility on campus.
 - A lot more information to come out for Heat Illness, and it is not negotiable. This will be in effect July 1, 2024.
 - A. Nowak asked if all AEDs should be registered, the answer is yes, all AEDs should be registered.
 - M. Diaz asked the timeline, the answer is by July 2024.

 - Reminder was shared that there is no charging for weekday games, only Friday night games. If there is no school on Friday, you can charge on Thursday per Blue Book.
 - Sites can charge for non-league games, if following ASB fundraising rules. The site that is charging for tickets must let the opponent know.
