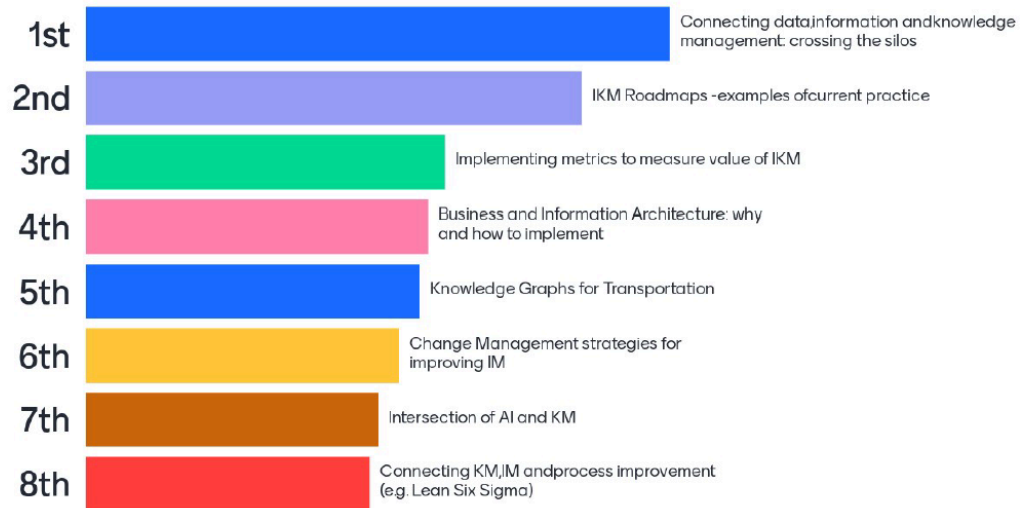

Each committee will be allocated 2 podium sessions. August 1st is the deadline for paper submittals; all sessions must be finalized by October 1st.

Check it out, pass it on, and or apply here: https://www.governmentjobs.com/careers/washington/wsdot/jobs/3509267/knowledge-management-strategist-wms-band-3 • Tony Geara (City of Detroit) is working on a new digital data platform • Rachel Cole (Northwestern University Transportation Library) reports that Roberto Sarmiento has retired. She also provides information about upcoming Special Libraries Association (SLA) events including quarterly transportation collections happy hours and the annual conference in July 2022. There is a call out for presentations. There will be two transportation-focused sessions related to workforce disruption and transportation library partnerships. • Enid White (Wyoming DOT) reported that the 2022 TRB State Representatives/National RAC Meeting will be held in Newton MA July 24-28. See the conference page. • Enid also noted that it is the 31st anniversary of the ADA, and encourages people to create 508-compliant documents and presentations. • Paul Tykodi (MassDOT) noted that there have been improvements to Microsoft SSRS in the last release that have improved support for 508 compliance. She also recommended checking out the dataversity website for information.

<p>12:50-1:30</p>	<p>2023 TRB Meeting Planning (Frances Harrison)</p>	<ul style="list-style-type: none"> ● Our mentimeter poll (see below) found that the highest ranked ideas for TRB sessions were related to connecting information and knowledge management efforts across organizational silos, developing IKM roadmaps and implementing IKM metrics (though there is a current KM research project that is anticipated to cover metrics so we may want to wait on this.) Several other topics were suggested in the poll (see below) ● Other suggestions discussed following the poll included: <ul style="list-style-type: none"> – business process documentation – information architecture (deciding what information is corporate vs. departmental vs office) – corporate data models – culture change for improved IKM – creating longevity in IKM functions (what documentation needs to be in place) – shifting to a cloud environment – greater reliance on data classification/ – taxonomy and search (as opposed to folder navigation) – tapping into APQC – see if they would make a presentation – “Deep Smarts” – nature of expertise (see Dorothy Leonard) – Gamification (revisit Accenture example from the KM domestic scan) – Evolving/emerging terminology (e.g. for environmental justice, interdisciplinary work where there is not much published work) – Supporting evolution in taxonomies using ontology tools ● Next step is to narrow these down and get volunteers to help put together some sessions. <i>Please email Kendra and Frances if you are interested in helping out with this.</i>
