

## NOMINIATION MEETING NOTICE

## USW LOCAL 9460, District 11 February 22, 2024

Elections for our Local Union officers will be this April. To prepare for that election, we are accepting nominations for the following positions: President, Vice President, Financial Secretary, Treasurer, Recording Secretary, Guide, Inner Guard, Outer Guard, three Trustees, Unit Chair, Unit Secretary and Unit Griever. You can nominate somebody (including yourself) for one of these offices by submitting the nomination form.

As provided in the USW Elections Manual, any member who has paid their initiation fee and is in good standing at the time of nominations is eligible to nominate candidates. To be eligible to be a candidate for office, a member must have been in continuous good standing for a period of twenty-four months immediately preceding the month in which the election is held (April 2024). The Local is waiving the 1/3 meeting attendance requirement as a condition of eligibility for nominees. The term of office will run for three years beginning in May of 2024. Also, please note that if you are nominating someone for a Unit specific position (like for example, Unit Chair of the St. Luke's Hospital), you must be a member of that unit.

Nominations must be submitted in writing to the Local's Recording Secretary no later than March 22, 2024. No electronic submissions are permitted – they have to be either dropped off in person at the union office (our hours are M-F 9am to 5pm), or otherwise they can be mailed in. Just note that the forms have to be at our office by 5pm on March 22.

Nominations will be tabulated at the Duluth Labor Temple on 3/22/24 at 5:01PM. Observers are welcome but must call ahead to RSVP. Once all of the nominations have been processed, a ballot will be prepared and mailed out to everyone to vote in our elections this April.
